D. REVIEW COMMITTEE MISSION STATEMENT

DISCUSSION	Within and to the support of Wisconsin Conservation Congress process; it is the mission of the Mississippi River Committee (MRC) to advise the Wisconsin NRB and Department of Natural Resources on issues, rules, or policies which affect the river and/or other associated natural resources. The MRC strives to stay acquainted with current river resource management; the science in support or opposition to that management; and with public opinion thereof. The MRC encourages river management agencies to seek public participation in management decisions or policy. Influence stemming from the MRC shall be generated with greatest intentions toward long term benefits to all fish and wildlife resources; and with an emphasis toward preserving public access and harvest of game resources, (i.e., preserving outdoor heritage activities of hunting, fishing, and trapping).

	<p>DISCUSSION</p> <p>Mike Britton read the resolution. David Heath shared a power-point like presentation on fisheries information including sizes, numbers, harvest estimates, growth rates, factors affecting mortality and many other aspects of the river and Lake Onalaska. The presentation will be attached. This was an excellently prepared presentation that was very specific to the resolution.</p> <p>Bob Jumbeck sent an e-mail in lieu of his absence: Committee – Unfortunately I will not be able to join the meeting tonight as I have a scheduling conflict. I do want to express my thoughts on resolution 320221.</p> <p>From a law enforcement stand point it is always best to try and have consistent regulations whenever possible. The river in particular has been subject to challenges, particularly in the recent past with bluegill limit differences</p>	

	<p>from pool to pool depending on what side of the river you fished. MN and WI have done really good things to work cooperatively in the process of getting the majority of bag limits in line with each other up and down the river.</p> <p>I feel keeping consistent regulations outweighs a 5 fish reduction on ½ of 1 pool. As for the license fee increase, that of course is a legislative decision / process. Jumbeck.</p> <p>Rick Wayne - Question about Bass numbers (predators) and their effect on panfish populations? Troy Hanson (author)- mentioned growing number of pelicans and cormorants. Mike Britton - Question on how long it takes for bluegill to reach 8"? Ed Peters - Question/comment on flathead catfish population and effect on panfish - especially bluegills? - Mentioned a Nebraska study that indicated high predation on panfish by flatheads. Dan Heidel - Question clarifying that this would cause Onalaska to be only pool/water body on river to have 10 bag rule? - answer was yes. Travis Burce - Comment that Minn. utilized the 10 bag rule for a period of time - felt fishing was very good after the rule was in affect. Comment that he supports the resolution. Tim Morgan - Commented on Iowa's generous limits for years and likes the new reduced, 15 limit. Also commented that guides are taking a large chunk of the panfish. Wes Domine - Thanked Troy Hanson for submitting the resolution and for being involved in the process. Thinks that 15 limit needs some time to show affects. Troy Hanson - Commented that he understands that the 15 bag change is recent and the groups reluctance to make a change so quickly. Made a point of asking group what they would propose to control the human factors affecting the large burden on the resource? Barbara Dahlgren - Commented that she was in favor of resolution and explained that it would give us a very good test case and some good info on the effect of the 10 bag limit.</p>

Regulations




Conducted 2 years of public input. Included in-person meetings, and online surveys to develop and then refine proposed regulations.




Spring 2019 CC hearing: passed 5260 to 1461 (78%).

April 2020, a 15 bag limit each of Sunfishes, Crappie and Yellow Perch went into effect.




Lake Onalaska Area Panfish Population Status



Lake Onalaska had consistently low bluegill abundance from 2012, 2016 and 2020 compared to other Mississippi River surveys.




Lake Onalaska Area Panfish Population Status

MEAN SIZE AGE ONE PLUS BLUEGILL AMONG MISS. R. LOCATIONS




Lake Onalaska Area Panfish Population Status

Lake Onalaska had average perch size from 2012, 2016 and 2020 compared to other Mississippi River surveys.



Summary


- The most common panfish (bluegill) has lower numbers and smaller size than other Mississippi River survey locations. Perch are average.
- Similar to Lake Onalaska, Black River mouth has low bluegill numbers and small average size.
- Trempealeau Lakes has average bluegill abundance size.
- Is exploitation the reason for Lk. Onalaska differences?





There is evidence that bluegill harvest has a more noticeable effect in Lake Onalaska than other locations.

Lake Onalaska bluegill reproduction is high relative to other locations.






There is evidence that mortality of young Lake Onalaska bluegill has a more effect than harvest.

Summary



-
- Harvest is significant.
 - Survival of young-of-the-year bluegill has more of an effect.
 - This higher mortality occurs during ages 4 months to 16 months.
 - So, maybe habitat has more of an effect.
 - It's unlikely DNR would make a regulation change after implementing one so recently.
 - If MN did not go along with a regulation change, the goal of similar regs across state lines would fail.
