Ben H. - several vacancies coming up. 2023 lake surveys primarily in Walworth County. Evaluating panfish DISCUSSION regulations. Trout habitat at Bluff and Whitewater creeks. Statewide 4 new habitat advanced technicians (biologists) have been hired. Attended summit for walleye rehabilitation. Habitat work on Scuppernong Springs sponsored by TU. Golden and Nagawicka walleye surveys had good results. Acoustic study on Oconomowoc Lake. One musky migrated 17 miles. Hatched 6.5 million walleye into Koshkonog system. Looking at cuts in walleye stocking in SE region and other areas. Laura Schmidt- Lake Michigan. Staffing commercial and sportfishing position open due to retirement. Implemented electronic reporting for charters. 5000 trips recorded to date. Yellow perch spawning surverys showing increase to 210 fish. Stream surveys on Menomonee and Milwaukee rivers. Career fair at Havenwood State Park geared towards high school for natural resource careers. TAC for whitefish has been set. Mike Thompson - SE region secretary's director. Ozone air quality sampling taking place at Chiwaukee Prairie. Economic development - Microsoft Data Center construction will start in October. Marty Johnson - new wolf plan was released today. Randy Johnson is main contact. Dealing with brush and controlled burning. Waterfowl banding has started. Band on Tuesdays/Thursdays. Volunteers are welcom. CDAC council memberships renew this fall. Deer observation program has started. Summer game bird observations. Bong closing on 120 acres from Kenosha Unified School District. Pheasant stocking goal 75,000 birds. Up to 81% hatch survival. CWD surveillance similar to 2022. Projected statewide sample size is 19,000 heads. Waukesha - 11/319 positives, Milwaukee - 0/20, Racine 2/40 Kenosha 1/29. No EHD reports. Brandon Smith - secured permanent position for state owned shooting ranges. Angler R3 activities 70 events in Madison and Milwaukee areas. 2023 7 new conservation wardens. 4 have started, 3 this fall. Next recruit class will
