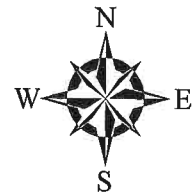

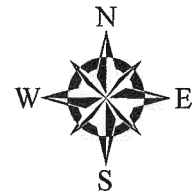
Trail 5 Rehab FR 320 to Reroute Sawyer County, WI T41N R6W

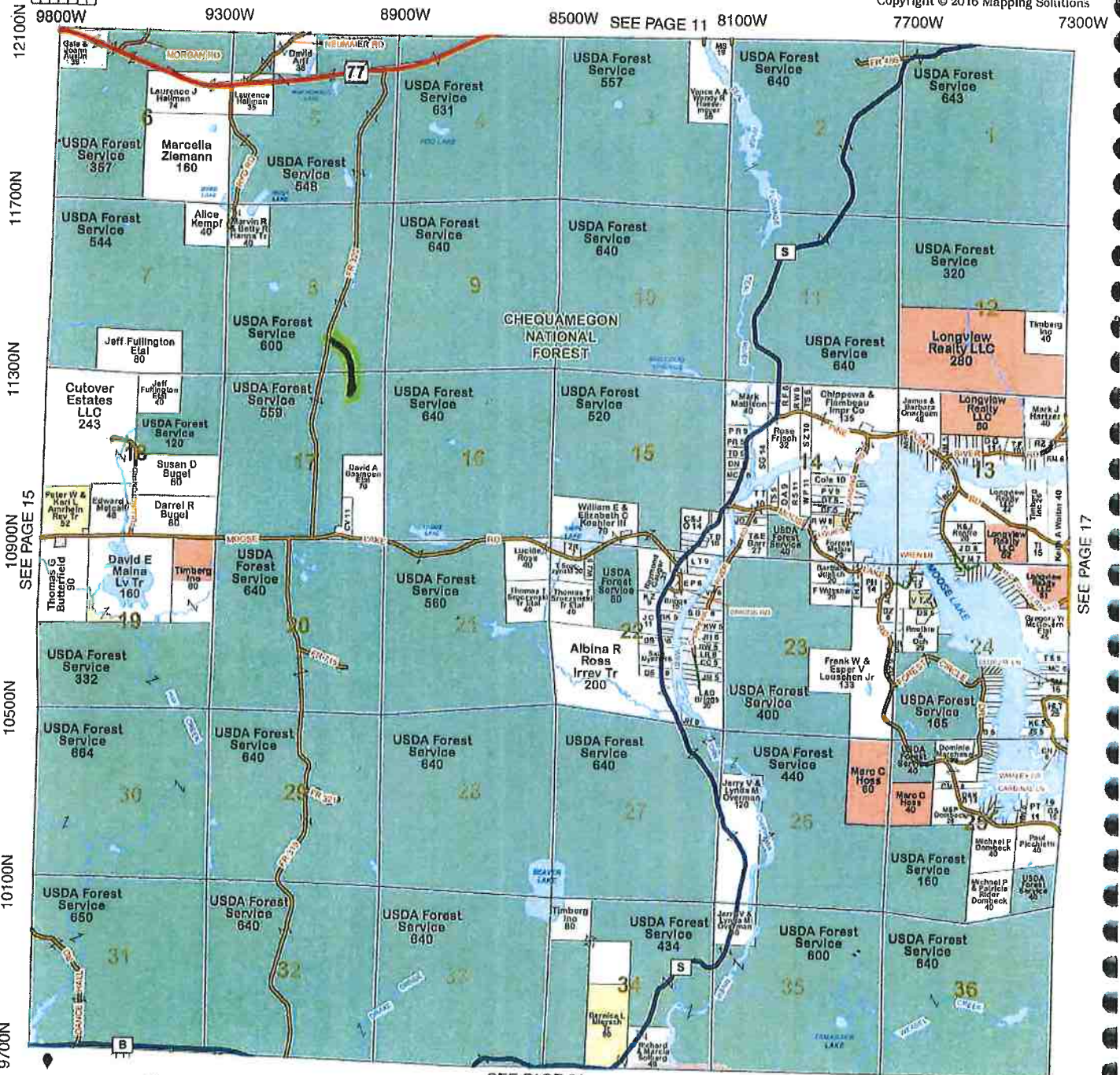
