**Project Description Summary** 

Langlade County proposes to develop a new ATV/UTV Trail / Troute totaling 2.4 miles including 2.2 miles of off-road trail and 0.2 miles of Gas Tax Troute. This trail will allow ATV/UTV riders access directly into the newly developed Perch Lake Campground and Charles De Langlade Park. This will then provide trail access to the park restroom and campground facilities and parking. Currently park and campground access by ATVs/UTVs is relatively uncertain as the Town has responded to resident complaints along Clear Lake Road near the Park entrance and has contemplated closing a segment of Clear Lake Road in front of the Park. This trail is also located in an area between the counties two large blocks of trials (Augustyn Springs and Parrish) and will allow riders to get off of road routes in between these blocks improving the riding experience and safety.

#### **Trail Project Detailed Description**

This trail development will include reconditioning of approximately 2 miles of existing woods roads and approximately 0.2 miles of new trail creation for use as an ATV/UTV trail in the Towns of Elcho and Ainsworth in Langlade County.

Work will include reshaping, drainage improvement, spot surface stabilization with gravel where need, brushing and minor trail expansion where needed on approximately 2 miles of existing woods roads. There will also be about 0.2 miles of new trail development which will include minimal tree removal, stumping, sod removal, brushing and stabilization of the surface with gravel.

Gravel will be utilized in order to firm up the trail surface where native soils are insufficient to handle traffic and where material is needed in order to raise the trail level to allow for proper drainage. Gravel depth will range from approximately 4 inches to 8 inches depending on existing trail conditions.

Gate will be installed on the new trail segments to limit access to ATVs/UTVs as shown in the attached maps.

A small (0.2) mile section of Troute will be located near the middle of this trail located in Charles De Langlade Park.

All sections of this trail will be signed appropriately as detailed in the trail signing handbook.

Hey Cody,

I wasn't able to open any of the shape files, just the PDF and photos. I'm making the assumption that fill material will be brought in to create level trail with gravel surface??

There appear to be a couple spots that could be potential wetlands, but hard to say from photos. Most of it appears in upland, but you'd likely want to take a look at the trail in at least these 2 spots.



If there is a fill road in place and the area is NOT considered wetland, then no authorization would be needed. Even though there may be fill in place, it may still meet definition of wetland which is the reason for the review.

If a permit is needed, we'd look at the standard alternatives analysis which would consider options of avoiding the wetlands where practicable. The fact that an area was previously filled will play heavily in decision. I'm not concerned about getting through a permit process if one is necessary if the wetland impacts are kept reasonable, but I'd first want to confirm presence/absence of wetlands and then take a closer look at the previously filled areas.

Good morning Scott,

I am working on an ATV grant for a trail development project in the Town of Elcho in Langlade County. I have attached a map from the SWDV with the trail shown and a shapefile of the proposed trail. I have also included some representative photos of the site.

This trail will be located primarily on existing logging roads with three small new sections. The project will consist of approximately 0.3 miles of new trail development and 1.9 miles of existing logging roads. The entire trail will be on high ground and are not anticipated to impact wetlands with one exception. The one location impacting a wetland is on an logging road that has an existing fill. This area is shown in the last two photos. The existing road is has about 18" to 24" of fill existing. Work at this location would remain within the existing foot print of the historic fill and would also include replacement of a culvert and addition of gravel over the existing fill. This project will have a storm water permit and the issue of potential runoff to wetlands and waterways will be addressed there.

I am looking for an initial assessment of likely permitting needs if any relating to your program and if permitting is likely needed, is a permit likely to be issued for the project.
