Project Description Summary

The Amott Area Star Riders Snowmobile Club is requesting a grant to address the significant safety concerns of Isherwood Hill in the Town of Buena Vista. Isherwood Hill drops a total of 72 feet in a total span of 425 feet. Currently there is a 50 foot segment of the hill that is at a 26 percent slope, another 50 foot segment at 25 percent slope, and a couple others that are around 20 percent. The hill contains dozens of exposed boulders, some estimated to be over 6 feet in diameter. The Amott club has determined that the best solution for this segment of trail is to bring in fill to cover the boulders and cover with topsoil to bring the majority of the slope to a 15 percent grade. This will eliminate the danger of the boulders and resolve the blind spots associated with the extreme grades that currently exist.
