- 4) Mountain Bay Gresham: From the Mountain Bay trail where it junctions with a number of trails north into the Village of Gresham. This trail is not ATV funded. It is 1.4 miles. No development dollars are being requested.
- 5) T Trail + This trail is 1.5 miles, connects MT Bay State Trail with access to fuel and amenities, not ATV funded, no development dollars are being requested.
