


## **Requested Trail Maintenance Funding**



- 1) Docs Trail: This trail is 5.3 miles in length. Connects corridor 547 with 20, following County RD S. This segment is not ATV funded. No development dollars are being requested.
- 2) Shortcut Trail: This trail is 1.7 miles in length but cuts off miles of trail for users getting around the town of Bonduel. It connects off the Mt Bay State Trail. This segme It is not ATV funded. No development dollars are being requested.
- 3) Tilleda Loop: This trail is 7 miles in length, it is a very scenic route meeting up with corridor 9. This segment is not ATV funded. No development dollars are being requested.
- 4) Mountain Bay Gresham: From the Mountain Bay trail where it junctions with a number of trails north into the Village of Gresham. This trail is not ATV funded. It is 1.4 miles. No development dollars are being requested.
- 5) T Trail + This trail is 1.5 miles, connects MT Bay State Trail with access to fuel and ameniti \$, not ATV funded, no development dollars are being requested.
