SFY 2024 SDWLP Project Priority List (PPL) - We hope to publish it during the second week of May.

June 30

SFY 24 SDWLP Application deadline if competing for Principal Forgiveness (reminder: submit plans and specifications to DNR Drinking Water and Groundwater as well as with the SDWLP application).

 Priority score reevaluation requests due within 45 days of SDWLP Application deadline date.

SFY 23 CWFP PF project readiness-toproceed deadline (ALL required bid documentation, including executed construction contracts, due).

SFY 2024 SDWLP Draft IUP and Webinar

The draft State Fiscal Year 2024 Safe Drinking Water Loan Program (SDWLP) Intended Use Plan was posted to our <u>Project Lists & IUPs page</u> on May 2, 2023, for a 30-day public comment period. We sent an email notification to approximately 2,400 recipients.

Intended Use Plan (IUP)

The SFY 2024 SDWLP IUP includes detailed descriptions of the changes made to the program relating to the implementation of the <u>Bipartisan Infrastructure Law (BIL)</u>. Thank you for your patience as we continue work to incorporate the additional BIL funding into our programs.

With the SDWLP application deadline approaching quickly (June 30), we want to provide a preview of some of the more noteworthy changes that are included in the State Fiscal Year 2024 SDWLP IUP:

- BIL-Funded Emerging Contaminants Program (PFAS)
- BIL-Funded Lead Service Line Replacement Program

Documenting BIL Signage Compliance

Municipal recipients of Bipartisan Infrastructure Law (BIL) funding are required to place a physical sign that displays the official *Building a Better America* emblem at the construction site. The sign must be placed in an easily visible location that can be directly linked to the work taking place and must be maintained in good condition throughout the construction period.

To document the use of BIL signage, municipal funding recipients or their authorized consultants must upload a photo of the sign to the <u>online system</u>.



After the loan closing, when DNR receives the municipality's next disbursement request, the assigned loan project manager will confirm whether an appropriate photo is uploaded.

The <u>BIL Signage Packet</u> contains guidance on how to design the sign; links to download the EPA and DNR logos; and logo variations, usage, and placement.

Due May 31 - ITA/PERF Deadline Waiver Requests for SFY 24 SDWLP Emerging Contaminants & LSL Projects

The first year of Bipartisan Infrastructure Law (BIL) Lead Service Line (LSL) funding and year two of BIL Emerging Contaminants (EC) funding for drinking water projects will be integrated into the regular Safe Drinking Water Loan Program State Fiscal Year 2024 funding cycle.

May 2023

Given that the details of these funding programs were not available at the SFY 2024 ITA/PERF submittal deadline, we are offering flexibility for those who may have missed the deadline.

ITA/PERF deadline adjustment

If you are interested in applying but did not submit an Intent to Apply (ITA) with Priority Evaluation and Ranking Formula (PERF) information by the October 31, 2022 deadline, or you would like to submit another ITA/PERF with a different project scope, you can request a waiver to this deadline (for SFY 2024 only).

Email your ITA/PERF deadline variance request and include the WAMS ID of the person who will submit the ITA/PERF to the appropriate contact by May 31, 2023 (earlier is encouraged):

Update New Officials' Contact Information

We need to have the correct contact information on file for the people in your municipality involved with a Clean Water Fund Program (CWFP) or Safe Drinking Water Loan Program (SDWLP) project, regardless of where you are in the funding process.

Please inform your DNR loan project manager of any newly elected officials and provide any new or updated contact information:

You must submit a complete ITA/PERF through the online system before you can fill out the application.

Application deadline

Submit SFY 2024 SDWLP Applications for LSL and EC projects though the online system by June 30, 2023.

- For EC projects include approvable plans and specifications and the additional SDWLP EC PERF (Form 8700-399), specific to EC Principal Forgiveness.
- For LSL projects include the additional updated SDWLP LSL PERF (Form 8700-383) and complete the Environmental Review (ER) module in the online system.

Guidance

DNR strongly recommends that you give yourself at least a couple of weeks to complete the online application.
