October 2

October 31

Market Rate Unchanged

There is no change in the market rate for financial assistance agreements approved by a municipality's governing body on or after October 1, 2023. The market rate for loans that have a final maturity of:

- 20 years or less will remain at 3.900%
- 21-30 years will remain at 4.100%

The Clean Water Fund Program (CWFP) and the Safe Drinking Water Loan Program (SDWLP) provide subsidy to buy down the market rate on loans (reduced interest rate loans). SFY 2024 CWFP PERF Score Reevaluation Requests

You may request a Priority Evaluation and Ranking Form score reevaluation within 30 days of the Clean Water Fund Program Principal Forgiveness Application deadline. Since the deadline falls on a Saturday this year, the deadline is extended to Monday, October 2, 2023, per s. 990.001(4), Wis. Stats.

• The deadline to submit a PERF score reevaluation request is **November 1, 2023**.

Reasons for requesting a reevaluation include: providing supporting documents that were not uploaded with the original submittal, correcting a PERF that was originally submitted on the wrong form, or correcting other errors.

Email the request and supporting documentation to the assigned DNR <u>Construction Management Engineer</u> and the CWFP Coordinator, <u>Lisa.Bushby@wisconsin.gov</u>.

Reminder: Obtain Plan Review Approvals Prior to Starting Construction

The department has recently observed an increase in the occurrence of municipalities commencing construction of reviewable projects without first obtaining approval of the plans and specifications.

This is a reminder that commencing construction without written approval is a violation of s. NR 108.03(1), Wis. Adm. Code.

Additionally, because the department is prohibited from approving projects after construction has commenced (s. NR 108.04(5), Wis. Adm. Code) and because plan approval is a required piece of a complete Clean Water Fund Program (CWFP)/Safe Drinking Water Loan Program (SDWLP) application, any entities that commence construction without plan approval are ineligible for CWFP/SDWLP funds.

As a reminder, the CWFP requires an approved facility plan and approved plans & specs, regardless of a "reviewable" or "maintenance" project classification. For example, an abbreviated form of a facilities plan, or engineering report, is required even for sanitary sewer replacement or rehabilitation projects, if seeking CWFP funding.

If you have a critical project timeline that requires approval by a certain date, please reach out as early in the process as possible to a DNR Plan Review Engineer to discuss your circumstances and schedule.

EPA Has Funding to Award

Apply Now for Drinking Water System Infrastructure Resilience and Sustainability Program Grant

Note: This grant program is offered directly through EPA. It is NOT a Wisconsin DNR grant program.

The U.S. Environmental Protection Agency has \$19 million in federal funds available through its *Drinking Water System Infrastructure Resilience and Sustainability Program* to award as grants to assist underserved, small (population of less than 10,000 people), and disadvantaged communities for the purpose of increasing drinking water system resilience to natural hazards.

Eligible applicants for this competitive grant program are public water systems, water systems located on areas governed by Tribes, and a State, on behalf of an underserved community. For-profit organizations and nonprofit organizations are not eligible to apply. Funding through this grant program must be used for the planning, design, construction, implementation, operation, or maintenance of a program or project that increases resilience of public water systems to natural hazards. The grant program is a competitive program. Applications must be submitted exclusively through <u>Grants.gov</u>.

Rule Revisions Effective Soon

September 2023

The Environmental Loans Section expects revisions to Chapters NR 162 and NR 166, Wis. Adm. Code, to go into effect in the near future.

In the upcoming months, we anticipate providing you with a compendium of changes and updated publications and web pages. More details about the rule revisions will be forthcoming in future E-Bulletins.

Background

The administrative rules for the Clean Water Fund Program (CWFP) and Safe Drinking Water Loan Program (SDWLP) were last updated in 2015. Since that time there have been changes to state statutes and federal regulations, and 2015 Wis. Act 55 took effect.

In addition, 2021 Wisconsin Act 112, which includes 2021 Senate Bill 489 – Procedural Changes for CWFP and SDWLP Applications, removed multiple barriers to streamlining the programs' application processes from ss. 281.58 and 281.59 and 281.61, Wis. Stats.

The current rule revision process started in late 2020. During the development of these rules, department staff worked with external advisory groups to get feedback regarding the existing programs and the proposed rules.

During that process, no external customers raised any issues, and there were no controversies regarding the proposed rules. Comments were received, however, during the public comment period regarding two sections of Chapter NR 166—those sections were revised in the proposed rule in response to public comments.

CWFP Energy Efficiency Priority Principal Forgiveness

Principal forgiveness policies are outlined in the annual Intended Use Plan. <u>Priority Principal Forgiveness</u> is an incentive that may be awarded in addition to general Principal Forgiveness (PF) with the caveat that no more than 70% of the total Clean Water Fund Program (CWFP) financial assistance amount can be awarded as PF.

 Energy Efficiency Priority PF will be awarded as a 1 to 1 match of the Focus on Energy incentive funds up to a cap of \$50,000 per project. Applicants are not required to qualify under the CWFP affordability criteria in order to be eligible to receive Energy Efficiency Priority PF. Municipalities who submit a CWFP Application after the September 30 PF deadline can still receive a loan and be considered for Energy Efficiency Priority PF if funds are still available.

To qualify for Energy Efficiency Priority PF, the municipality must be the recipient of an energy efficiency incentive from Focus on Energy.

Required documentation

Applicants must provide documentation of the incentive agreement from Focus on Energy. For prescriptive awards, the applicant will need to request pre-approval from Focus on Energy, in order to obtain an incentive agreement. This documentation is not required at the time of application submittal but must be provided prior to loan closing.

Applicants who want to claim Energy Efficiency Priority PF after submittal of their CWFP application, but prior to loan closing, should work with their <u>DNR Project Manager</u> to submit documentation and be considered for funding.

October 31 SFY 2025 ITA/PERF Deadline Reminder

If you wish to apply for State Fiscal Year 2025 funding, submit an <u>Intent to Apply (ITA)</u> with Priority Evaluation and Ranking Formula (PERF) information and supporting documentation through the <u>Online ITA/PERF System</u> by **Tuesday, October 31, 2023**.

Reminder: October 20, 2023, is the final submittal date for Online Submittal Authorization Certificates and requesting a WAMS User ID and DNR Switchboard access.

The ITA/PERF deadline applies to all types of projects funded under the Clean Water Fund Program (CWFP) and Safe Drinking Water Loan Program (SDWLP), including storm water projects and pilot projects.

BIL-funded projects

Municipalities that plan to apply for funding through a <u>Bipartisan Infrastructure Law-funded program</u> must submit a regular SFY 2025 ITA/PERF by the October 31 deadline. BIL-funded projects include:

- Lead Service Line replacements (both public and private) and related LSL inventory work
 - Submit a separate ITA/PERF for LSL-related work in order to be eligible for the 0.25% flat interest rate and LSL PF available only for LSL projects.
- Emerging Contaminants projects (PFAS-related drinking water and wastewater projects)

More eligibility and funding details for the EC Programs and LSL Program are available in the SFY 2024 CWFP and SDWLP Intended Use Plans. Note that the additional SDWLP EC PERF (Form 8700-399) and SDWLP LSL PERF (Form 8700-383) will need to be submitted with the financial assistance application, not with the ITA/PERF submittal.

Documentation

Be certain to upload relevant documentation for PERF questions that are applicable to your project. Refer to the "ITA Help Text" for information on acceptable documentation. If relevant documentation is not uploaded, then *zero points* will be granted for that question.

Changes to CWFP PERF score reevaluation process

The revised Chapter NR 162, Wis. Adm. Code, is expected to go into effect in the near future. There are two changes to the rule related to the CWFP PERF score reevaluation process:

- There will no longer be a 30-day PERF rescore period after the Project Priority List is published. There will still be a 30-day PERF score reevaluation period after application submittal.
- Only new information that did not exist at the time of the original ITA/PERF submittal will be considered as part of a PERF reevaluation request.

Given these changes, it is important to upload the relevant documentation with the original ITA/PERF submittal.
