

SDWLP Funding List Column Descriptions

The following descriptions explain the columns on the Safe Drinking Water Loan Program (SDWLP) Funding List.

1. **Priority Score** – The project’s Priority Score is the sum of Financial Need Points in #2 and Project Points in #3.
2. **Financial Need Points** – These points are calculated at 15% of the Total Principal Forgiveness (PF) Points in #15.
 - For example, if a municipality scores a total of 100 PF Points, they will receive 15 Financial Need Points.
3. **Project Points** – These represent the priority points that were calculated through the project’s Priority Evaluation and Ranking Formula (PERF) score. This score now excludes any points based off of financial need.
4. **Municipality** – The municipality requesting funding through the SDWLP.
5. **Project Number** – Assigned to the project once its Intent to Apply is approved, used by the DNR to track projects.
6. **Project Description** – A brief description of the project to be funded.
7. **Region** – The DNR region in which the project is located.
8. **Project Manager** – The DNR Environmental Loans Project Manager assigned to process the application and prepare the Financial Assistance Agreement (FAA) for the project.
9. **CME** – The DNR Environmental Loans Construction Management Engineer assigned to inspect the project and review/approve contract change orders.
10. **Population size** and 11. **MHI (Median Household Income)** – Determine the amount of subsidy in #12.
12. **Percent of Market Rate** – The interest rate subsidy percentage the municipality qualifies for, as established in [s. 281.61\(11\)\(a\), Wis. Stats.](http://s.281.61(11)(a).wis.stats) View current interest rates at dnr.wi.gov/aid/documents/eif/guide/Interest.html.
13. **Requested Project Costs** – The total amount of funding requested through the SDWLP at the time the application is submitted. This amount is subject to change prior to loan award.
14. **Estimated Loan Amount** – The estimated amount of project funding which will be provided as a reduced-interest rate loan through the SDWLP.
15. **Total PF Points** – The municipality receives points based on the [Principal Forgiveness \(PF\)](#) scoring methodology published in the Intended Use Plan (IUP).
16. **Eligible PF Percentage** – Determined by the municipality’s total score in #15.
17. **PF Estimate** – The estimated amount of PF the project will receive is calculated by multiplying the Requested Project Costs in #13 with the Eligible PF Percentage in #16. This amount is subject to the \$1,600,000 annual municipal cap and cannot exceed 70% of the total eligible project costs.
