The BSG included a proposal titled "Air Permit Certainty" in the 2015 BSG report to promote redevelopment of brownfields properties as new manufacturing sites by reducing cost and risk associated with air permitting. 2017 Wisconsin Act 70 included a provision directing DNR to implement a pilot program under which an owner/operator is not required to make changes to air pollution controls due to new or modified requirements (excepting those from federal Clean Air Act) for 10 years after DNR grants coverage.

Looking for volunteers to help develop this initiative and report to the Group (and the department) on the issue. Harrington, Thimke, Antaramian, Misky and Buzecky agreed to volunteer.

Staff provided a copy of the recent article that was published on the RR Report newsfeed website (https://rr-report.blogs.govdelivery.com/) (see RR Report PFC Article) regarding emerging contaminants. The Group's opinion is that they are dealt with at VPLE sites like at any other site. However, PFAO/PFOS creates some uncertainty. For VPLE sites, some assurance from DNR that the VPLE covers these emerging contaminants would be helpful. Group requested that staff create some guidance on what industries may have used these compounds. There is an ad hoc team at DNR reviewing a matrix of compounds and industries. The DNR is also looking at lab methodology to test for certain compounds.

Judy Fassbender will provide a draft document of the product that staff is working on. Group suggested that this might be something to discuss with the NR 700 Focus Group.
