10:05 2017 Wisconsin Act 70 – Brownfields and Air Program (Thimke)

30 min

In its 2015 report, the Brownfields Study Group (BSG) included a proposal titled "Air Permit Certainty for Brownfield Developments" in an effort to promote redevelopment of brownfields properties as new manufacturing sites by reducing cost and risk associated with air permitting. 2017 Wisconsin Act 70 included a provision directing DNR to implement a pilot program under which an owner or operator is not required to make changes to air pollution controls due to new or modified requirements (excepting those required by the Clean Air Act) for 10 years. Thimke provided an update of the work to date and invited participation from interested BSG members or guests to participate in an advisory group working with the DNR. Update from Thimke regarding recent legislative consideration to protect landowners from having to incur costs related to cleaning up property they purchased but did not contaminate. 11:00 Lender Liability Subgroup – report out/finalize recommendations (Thimke)

Thimke provided a summary of the lender subgroup's efforts to date. Previously, the BSG recommended evaluating whether the statutory definition of lender should be expanded considering evolving lending requirements. A table of

issues and recommendations submitted by the subgroup was approved by the BSG. The table is on the BSG website. BSG did not recommend statutory changes at this time.

11:10 VPLE improvements subgroup (Thimke)

Thimke introduced the topic and the BSG discussed: Does the RR Program's VPLE program need improvements? Is it underutilized and why? BSG suggested that some people believe that VPLE is too expensive and time-consuming. Can the program be improved? Should DNR consider providing a fact sheet / guidance on VPLE to dispel misunderstandings? Also raised the notion of how VPLE would work considering emerging contaminants. The BSG decided to discuss this further at the next meeting and the BSG would discuss at the next meeting whether there is a need to form a subgroup to examine the issue. 11:15 Clean Soil Guidance (Fassbender)

Judy Fassbender (DNR) provided an update on draft guidance "Clean Soil Management: A Self-Implementing Option for Soil Excavated During a Response Action under Wis. Admin. Code chs. NR 700 through NR 750" (RR-103). The draft guidance is open for public comment until May 24. The current version of the draft guidance includes modifications made in response to comments received when the guidance was initially out for comment in 2017. In the current version, the contaminant content criteria for meeting the clean determination include minor changes from the initial version. The applicability of the guidance has been substantially narrowed. The current version of the guidance is intended solely for use by responsible parties who are managing soil excavated as part of a response action pursuant to Wis. Stat. ch. 292. 1:45 Emerging Contaminants Update (Foss)

5 min

Foss provided brief remarks regarding emerging contaminants. The RR program maintains a Wis. Admin. Code ch. NR 720 <u>spreadsheet</u> with soil residual contaminant levels (RCLs) that were calculated using U.S. EPA's Regional Screening Level (RSL) web calculator following the procedures in Wis. Admin. Code § NR 720.12, for determining soil direct-contact RCLs protective of human health. The DNR has authority to require that the responsible party develop a site-specific clean-up standard for all contaminated environmental media in accordance with Wis. Admin. Code § NR 722.09, if no numeric clean-up standard otherwise exists. For more information, see the <u>February 1, 2018 article</u> posted in the *RR Report* newsfeed. The BSG requested additional discussion on this topic, including the status of PFOS/PFAS.

Federal Legislation Update (Scott Wilson)

• Federal budget included the BUILD Act which reauthorized the EPA Brownfields programs and made changes to them.

- EPA Grant Guidelines are currently being rewritten and will be available in late August or September. Several significant changes expected.
- New EPA grants will expand recipients of federal brownfields funds to include non-profits and CDAs.
- Increases size of cleanup grants from \$200k to \$500k with waiver to \$650k.
- Creates multi-purpose grant for up to \$1M to include inventory, planning, assessment & cleanup.
- Some administrative costs are now eligible for reimbursement under the grants.
- Criteria for awards may include whether a site is located adjacent to a body of water or within a
 federally designated floodplain and whether the redevelopment brownfield site will create renewable
 energy.
- It also extends the definition of a bona fide prospective purchaser to include lessees of property who enter a lease after January 1, 2002, (effective date of the 2002 act) and who meet the other criteria for the bona fide prospective purchaser defense.
- States and local governments that acquire properties through seizure or other law enforcement
 activities are excluded from CERCLA's definition of owner and operator, word "involuntary" was
 removed. Local governments who acquired property before 2002 even if local government didn't do all
 appropriate inquiry, can get EPA grants as long as they didn't cause or contribute to pollution.

EPA Meeting Summary (Thimke & Misky)

BSG Co-Chairs Mark Thimke and Dave Misky recently traveled to Chicago to meet with EPA officials regarding Wisconsin brownfields initiatives. They shared the BSG's 2015 report: *Investing in Wisconsin* and the economic report commissioned in 2015. They spoke about the critical 128a funds that Wisconsin receives to administer its brownfields initiatives. They also briefed EPA officials on the 2017 Wisconsin Act 70 – Brownfields and Air Program and invited EPA representation at BSG meetings.
