Review Takeaways from Last Meeting

- Meeting notes and materials from Sept. 7 2023 meeting
- Steven Wiley (City of Ashland) shared that the city has applied for an EPA grant but hasn't been successful the last two times; need to reevaluate the approach and the application if they choose to reapply again. Many municipalities with smaller staff rely on consultants to help with grants because it can be a challenge to apply and administer the grants.

Overview of General State Budget Process and Timelines, DNR

- The funding process is lengthy and involves lots of people, including legislature and NRB.
- Think about categorizing the work of the subgroup into easy successes, long-term changes, and the middle area that lies between the two.

Funding Gaps Prioritization Activity

- Reviewed funding gaps (attached to agenda)
- Objective of activity: Identify the top five that need to be prioritized.
 - Outcomes: Vapor sites without an RP, address community health concerns, flexible cleanup funding, emergency water for private wells, small businesses that can't pay for cleanup

Remediation and Redevelopment External Advisory Group

- General discussion after activity results
 - o Vapor and emergency water -- Both have an acute risk. Funding is needed.
 - DERF insolvency –The stalled sites have a domino effect on the community and connects to
 other funding gaps such as vapor sites without RP, community health concerns, and small
 business that can't pay for cleanups.
 - Small businesses that can't pay once funding is acquired for small businesses, then
 prioritization can begin.
 - o **Holistic funding for technical resources** –By offering resources to the community, can help them move forward through liability protection and grants for funding for the project.
 - Next steps could include understanding the budget, legislative, and statutory processes better to draft a proposal.

Ready for Reuse (R4R) – Gena Larson, DNR

- Program overview
- Increase program interest brainstorm and discussion.
 - Site investigation must be complete to be eligible—this is a program rule. Money comes from 104K EPA Federal funding, we compete nationally for funding.
 - o Open cooperative agreement covers cleanup only.
 - o Closed cooperative agreement is the most flexible, can pay for investigation also.
 - Municipalities are strapped for cash, especially rural areas. Often, don't have time or staff resources that would qualify for R4R.
 - o Contact league of municipalities and share a flyer to be passed along to members.

Agenda Repair: Summary of the last year of RR EAG Funding Sustainability and next steps in 2024

- Started Nov. 2022 focused on data, gaps, inequities, and deficiencies.
- Currently have one proposal.
- Will work toward solution driven agendas. Goal is to develop a resolution moving forward.





Budget Proposal Timelines



New funding and programs, changes to existing funding, etc. for all agencies is included in the biannual State Budget

- DNR Programs submit budget requests to Secretary's office
- DNR goes to Natural Resources Board
- DNR Submits Budget Requests to DOA/Governor

Review of Identified Funding Gaps (List #1)

- A. Dry Cleaner Environmental Response Fund (DERF) insolvency
- B. Resources for long-term maintenance of vapor impacted properties
- C. Stalled leaking underground storage tank sites due to Petroleum Environmental Cleanup Award (PECFA) sunset
- D. Resources for emergency water for contaminated private drinking water wells
- E. Funding for innocent landowners people who acquired property and can demonstrate through due diligence that contamination was not suspected at the time of transaction
- F. Funding for sites where a small business owner or small business whose operations caused contamination but they can't afford to pay for cleanup

Review of Identified Funding Gaps (List #2)

- G. Sites where a local government and/or local businesses want to redevelop but there is a responsible party who is not doing the cleanup or making sufficient progress with cleanup
- H. Funding for holistic technical assistance to community groups or local governments (e.g., from liability planning to redevelopment)
- I. Funding to support citizens or neighborhood groups that are concerned about the health and safety impacts of contaminated sites in their communities
- J. Flexible cleanup funding
- K. Sites with known or potential vapor issues and no responsible party

Funding Gap Prioritization

What criteria should be considered in picking the top priority funding gaps to evaluate further?

- Broad public benefit
- Benefits to human health
- Equity, how much will this lead to improvements for under-resourced communities.
- Feasibility likelihood that some action could successfully be taken to address the gap
- Program purview Is this beyond the DNR's purview but something another agency may be more efficient in addressing?
- Duplicative effort Are others already working on this topic?

 - Interest-free
 - Flexible payback terms
 - Applicant must be municipal
- Currently \$2.9M available (approx. \$1.745M closed CA, \$1.245M open CA)


Ready for Reuse
