The notification shall occur no later than 60 days prior to the request for a certificate of completion on the property. The voluntary party or parties shall submit a revised application to clearly demonstrate the boundaries and legal descriptions of the properties for which the applicant is seeking the liability exemption. The applicant shall notify the department if they intend to request the exemption for the property initially submitted with the application or request to modify the property boundaries in accordance with s. 292.15(2)(at).
