Highlights

- The forest products industry ranked 13th and 2nd in terms of the number of employees and industry output in the state, respectively.
- The average annual income in the forest products industry was \$78,000, \$12,000 higher than the state average.
- Every 10 jobs in the forest products industry supported an additional 12 jobs in the state.
- Every million dollars of output in the forest products industry generated an additional \$553,000 output in the state.
- The forest products industry generated 1.54% of jobs, 3.3% of output and 2% of value-added in the state.





Forest products industry direct gross output share




Forest land acres by ownership (source: FIA 2022)

Forest sectors value-added in million dollars

- **DIRECT EFFECT:** Industry's own production.
- INDIRECT EFFECT: Inter-industry purchase in response to direct effect.
- INDUCED EFFECT: Household spending from the consumption of goods and services using income generated from direct and indirect effects.
- TOTAL EFFECT: Sum of direct, indirect and induced effects.
- EMPLOYMENT: Full- and part-time employees and self-employed individuals.
- **LABOR INCOME:** Sum of employee compensation and proprietor income.
- **INDUSTRY OUTPUT:** Total value of production by the industry in the given year.
- VALUE-ADDED: Sum of employee compensation, proprietor income, other property income and taxes on production and imports less subsidies.
