At this time, Mixed Products (by cord or ton) for **Aspen, Jack Pine, Mixed Hardwood, Basswood, Yellow Birch and White Birch** cannot be reported on the Cutting Notice and Report of Wood Products from Forest Crop and Managed Forest Lands (form 2450-032). To obtain a 3-year weighted average, we are continuing to collect data for these Mixed Products; this is the third year of collection for these product and species code combinations.

Stumpage rates will not be established for November 1, 2017 through Oct. 31, 2017 for this new combination of product and species codes.
