August 2020 Meeting Minutes 10:00 am – 12:00 noon, Friday, Aug 7, 2020 Virtual Meeting held via Skype

Agenda repair. Feb 2020 meeting minutes: Chair, Jim Zellmer, called meeting to order; approval of May 15, 2020 meeting minutes: Brad J. motion, Ken B. second – approved by voice vote

2020 GCC Repot to the Legislature: Bruce Rheineck (DNR) reported that draft Report to Legislature is now available for review/edits; requested that agencies review revised Executive Summary and Recommendations sections and get comments back to Bruce

FY 2022 Joint Solicitation update: Jen Hauxwell (UWS) reported that FY 2022 Joint Solicitation request for proposals (RFP) posted/sent out on Jul 23; potential interested researchers notified by e-mail; webinar to be held Aug 25 to provide info and answer questions on RFP; estimated approximately \$400,000 available from all agencies to fund projects this coming year (FY 2022)

<u>GCC Logo:</u> Jim Z. reported that approved GCC logo finalized and is now available for use

FY 2022 JS Research Project issues: discussion of how GCC research funding opportunities might be better provided to increase racial and ethnic diversity; noted that GCC agencies have engaged with tribal groups on issues in the past, including mining and wild rice issues; suggestion that Policy & Outreach Subcommittee investigate opportunities for input on improving diversity in GCC project funding; suggestion that follow-up on this topic be presented at a future meeting

Discussion of possible GCC meeting at Capitol highlighting research informed policy:

suggested was to focus on areas with significant completed GCC funded research, such as arsenic or radium; how research relates to agency policy should be stressed; GCC members to suggest 1 to 3 topics for Capital meeting (through agency Subcommittee rep) that Policy & Outreach Subcommittee can work on

Technical Presentation: Katie Hein (DNR) provided presentation on *Linking groundwater and climate to understand long-term lake level fluctuations in Wisconsin*; project involved investigation of lake level - groundwater connection; focus was on natural fluctuation of seepage lakes and how climate change might effect long term lake levels; objectives included gathering and evaluating historic records and data; found two distinct regions in W influenced by different precipitation patterns; factors influencing lake levels included precipitation, elevation, soils and forest cover in vicinity of lake; created both empirical and process based models, and used them to hindcast levels on seepage lakes with no historic lake level record; models can be used to predict lake response to precipitation and improve lake management

Agency Updates:

DHS: Roy I. reported that agency currently working on Cycle 11 groundwater standard recommendations; *manganese in drinking water* fact sheet completed and posted on web site; agency assisting with Marinette JCI/Tyco PFAS investigation/private well sampling results; Sarah Yang (DHS Toxicologist) interviewed for Clean WI documentary on nitrate in groundwater

DATCP: Mark M. reported DATCP Standards Oversight Council (SOC) working on verification of bedrock depth Technical Standard - now reviewing/responding to public comments on draft standard; agency working with USGS on aerial electromagnetic assessment in northeast WI to determine bedrock depths of 5-20 ft; facts sheets for Cycle 10 groundwater standard recommendations prepared and now posted on DATCP website; agency assisting with Aug 25th NR 140 Stakeholder meeting on recommended Cycle 10 pesticide standards

DSPS: Brad J. reported agency at peak plan review period as this year not a wet spring so good year for onsite system construction; continued assessment of effectiveness of site evaluation of high groundwater level methods – now collecting data and reviewing currently allowed methods

DOT: Bob P. reported agency continues with Wisconsin PFAS Action Council (Wispac) PFAS related activities

UWS: Jim H. reported that good campus Covid testing has allowed UW research projects to progress - labs now open, field work underway; Water Resources Institute Postdoc Fellows now at DHS and DNR, Postdoc now in ecology group at Duluth EPA lab; 2 other Postdocs doing PFAS toxicology/research at Duluth; funding for new Fellow available in Feb/March 2021; Sea Grant Scientist position in aquiculture posted

DNR: Jim Z. reported that NR 812 rule changes went into effect July 1; Certified Operator exams available online, being done by external partners; new WI AG opinion issued that DNR has authority to consider cumulative impacts in evaluating water use issues – WI Supreme Court to hear related case this fall; agency continues work on Central Sands Lakes study; WI PFAS Action Council action plan expected late this year; Water Initiatives Steering Committee (WISC) nitrate reduction study group efforts continuing; rulemaking underway on NR 140 groundwater standards, NR 809 PFAS MCLs, PFAS surface water quality standards and NR 151 nitrate rules; Town of Armenia groundwater study contracts now completed; RR Program reporting 30+ PFAS sites now under investigation

WGNHS: Ken B. reported that Carol McCartney had retired on July 1, agency cannot yet hire replacement so dividing her tasks; agency staff working on bedrock geology in Quad west of Devils Lake; working with USGS on air born ground truthing project; working with US Forest Service under "Good Neighbor Authority" agreement inventorying groundwater/geological resources and investigating groundwater–surface-water management issues; new monitoring wells installed in sandy area of Bayfield Co.; working on project in southeast WI on bedrock controls of arsenic in groundwater; working on Platteville Pioneer Farm study of groundwater conditions using real time groundwater monitoring; assisting with study of neonicotinoid pesticides in Central Sands
