Stats., but it may not be disclosed by the DNR to anyone except the Departments of Children and Families, Workforce Development or the Department of Revenue. Personally identifiable information collected will be used for administrative purposes and may be provided to requesters to the extent required by Wisconsin's Open Records Law (ss. 19.31-19.39, Wis. Stats.).

Training on captive **pheasant, gray partridge, bobwhite quail and other quail species of the subfamily Odontophorinae** require the use of leg bands, if the birds will be released and killed during the training activity.
