  - 9-member council
  - UW-Madison will appoint members to represent WSLH
  - Members may serve for 3-year terms
  - A person may not serve more than 2 consecutive terms as a member on the council
- ss 15.09 (1)
  - Fixed terms shall expire on July 1
- ss 15.09 (2)
  - Officers are selected at the first meeting each year
  - Elect a chairperson, vice-chairperson, and secretary from members
  - Officers maybe be reelected for successive terms

New member start date is first meeting that they are present to vote. Members that start before July will use the next July date as the beginning of their 3-year term used to determine the expiration date of member service.
