In accordance with s. 295.44(3)(e), Wis. Stats., Gogebic Taconite has maintained a surety bond for 1-year from the issuance of the Certificate of Completion on November 16, 2023.

The Department has determined that Gogebic Taconite has continued compliance with all provisions of Ch. 295, Wis. Stats. Completion Report Exploration License #41002 Vegetation at Exploration Hole 655-1 September 2024

Purpose

Documentation of site conditions at Exploration Hole 655-1.

Vegetation Inspection

On September 10, 2024, a representative for Gogebic Taconite visited the site. Vegetation approaching the site was thick with the forestry road appearing to have been mowed. A stake with the exploration hole collar has been highlighted in Photo 1.



Photo 1: Site Condition as viewed from existing forestry road.

Photo 2 illustrates the vegetation as appearing from the forestry road looking towards the exploration hole 655-1 collar. Vegetation is thick.



Photo 2: Site condition as seen from the forestry road looking towards the exploration hole collar.

Photo 3 illustrates the general conditions at the collar. Note that the collar is within the shade area of the site.

Photo 4 illustrates a close up view of the grout cap located at the collar. The grout cap remains intact and there is no evidence of artesian water flow from the exploration hole.
