# **Introductions and Member Updates**

<u>Keith Pamperin</u> – From Green Bay area. Very involved with Challenge Outdoors. Serves on the Wisconsin Wildlife Federation. Keith is currently vice-chair and has served on the DAC as a long-time member.

<u>Calvin Richtig</u> - From Green Bay Area, works for Options for Independent Living. Calvin is currently the Chairperson of the DAC and has served for approximately five years. He also serves on the Assistive Technology Advisory Council.

James Chitek – WI DNR Customer Service and Outreach Supervisor.

<u>Lindsay Muench</u> One year anniversary on the DAC. She is very interested in the outdoors (hunting and fishing) and is a hunting safety instructor. Lindsay is also involved with Adaptive Sportsman and participates on a competitive wheelchair soccer team on a national level.

<u>Jack Hiem</u> – primary outdoor involvement is with adaptive climbing. Wisconsin Adaptive Climbing trip to Devil's Lake is June 27th, 2025.

<u>John Martinson</u> – Previous Chairman and has served on the DAC since 2010. Vice Chair of Adaptive Sportsmen. John has also been advocating for spinal cord research. SB99 is currently going through the Senate; the bill is about targeting functional recovery for spinal cord injury and finding a permanent solution. Assembly Bill #92. John enjoys scuba diving and riding his motorcycle as well as hunting.

<u>Amy Carlson</u> – Amy is an advocate for Parkinson's Disease and has been participating in a successful clinical trial. Keeping busy and moving is good medicine, but getting out in nature is the best medicine (for brain stimulation). She is involved in the Davis Phinney Foundation which is a Live Well with Parkinson's nonprofit organization. Amy was recently featured at Lawrence, KS campus of the University of Kansas, as a MOTH storyteller.

<u>Kirsten Engel</u> – Executive Director at the Autism Society. Has served on the DAC since approximately 2010, previously worked at Independent Living Center doing ADA and assistive

Shannon Holt – DNR Facilities Management Office and DAC meeting Facilitator.

<u>John Fritz</u> – John has been with the DAC for three meetings now. John is a totally blind person who runs a vending company and greatly enjoys hunting. John is involved with helping landowners get sponsored for places for people with disabilities to go hunting and teaching hunting to persons of all abilities.

<u>John</u> Mitchell – John lives near Milwaukee in Greenfield. He has been very involved Adaptive Sportsman's over the years (events are on the website <a href="https://adaptivesportsmen.org/">https://adaptivesportsmen.org/</a>) and served on the Independence First board for 13 years.

## **Budget**

Wisconsin's 2025-27 state budget is currently being debated by the legislature. The Joint Finance Committee is in the process of disassembling the Governor's proposed budget and rebuilding it. The deadline for passing the budget is June 30, 2025.

# **Cabin Reservations/ Campsites**

This project is being turned over/taken over by parks. Parks and Recreation Bureau Director, Steven Schmelzer, has a team working on this. The parks team is currently developing an email form for cabin reservations (available date for use TBD) and is also changing the reservation process to be ran centrally in coming years. They are also looking into the possibility and feasibility of adding cabin reservations to the CAMIS system. The parks team has developed a list of goals, and they would like this group's feedback and help prioritizing.

Accessible Cabin Reservation System Goals include:

- Prioritize access for those with the greatest need
- Promote equitable and rotational access
- Improve transparency of selection or allocation methods
- Support diverse accessibility needs
- Increase awareness of the accessible cabin program
- Streamline the application and booking process for users
- Enable real time notification of cancellations or openings
- Coordinate cabin and campsite reservation windows for group travel
- Reduce manual workload for park staff

#### **Hunter Safety**

R3- Recruit, Retain, and Reactivate program is launching an online program geared toward people with disabilities. This course would be an optional companion course that focuses on adaptive equipment and introducing the community to adaptive equipment. The DNR is looking for outside organizations to partner with that has access to adaptive equipment and would allow use of their equipment for training purposes. Adaptive Sportsman can help.

#### **Accessibility Fund**

Being launched soon by Natural Resources Foundation (NRF). Nick and Bret have final meeting next week. Once up and running, credit card donations will be accepted on their website; <a href="Natural Resources Foundation of Wisconsin">NRF will take a 20% administration fee for their services</a>. Funds will be used for general accessibility projects and equipment. Funds raised through donations may also be used to match grants from parks Friends' groups.

#### **Bylaws**

Calvin would like council members to review the bylaws as it has been probably 10 years since the last review. Members should review the purpose and role of the DAC and consider any changes or revisions that are to be made to the bylaws. This can be a long-term project/goal of the council. Every state receives federal Assistive Technologies (AT) funding, yet Wisconsin is one of only three states that has a Disability Advisory Council. This led to discussion of how WI compares to other states.

### **Accessibility Programs of Other States**

Calvin to start an Excel spreadsheet for other state programs to create a database for DNR websites and accessibility websites that other states offer. This will be a live document shared with the group that all can add to. It may be beneficial to compare what other states and to network with them to be able to share ideas back and forth. It does seem that Wisconsin is one of the leaders for state-run programs. We can also model accessibility features of national parks.

A sub-committee was formed to find what states would be good for Wisconsin to emulate. Sub-committee volunteers are Amy, Calvin, Kirsten, and Lindsay. Once good examples are found, Nick and Calvin will reach out for networking in the future. This item should be kept on the agenda moving forward.

# **Accessibility Coordinator Updates**

- <u>Kayak Launches</u> New launches at Pike Lake and Yellowstone Lake State Parks.
   Design flaw noticed with the sliding plank and bolt placement, as well as the transfer bench being too high. Nick has contacted the manufacturer (Mod-U-Dock) about these issues. There have also been a few instances of the crossbar being installed incorrectly.
- Outdoor Wheelchair Program Nick and Parks team (Deanna Sell) nominated for an award from the Governor's Office.
- <u>Speaking Engagements</u> Nick is available for speaking engagements for groups. Calvin mentions that Farm Technology Days has been one of their most successful

- shows for the statewide ADT program.
- <u>Shower Modifications</u> Nick spoke with Engineering and Construction Management Section leader, and they will incorporate more hooks, including lower hooks for guide dogs on all future shower designs. Jack suggested the idea of having different/textures surfaces to indicate in front of the door.
- Reappointments All reappointments are up to date. Moving forward, all reappointments will be done in December for the next 3 years, so terms will run longer than 36 months.
- State Fair State Fair 2025 is from July 31<sup>st</sup>- August 10<sup>th</sup> in West Allis. Chad, Action Track Chair state rep. is working with Parks to allow the DNR to borrow a chair for display during the state fair. Parks has a booth that Nick can use for accessibility awareness. Nick is still working with/ waiting for communications on new brochures and printed materials.
- <u>Hunting Blinds</u> Proposed rule change to allow hunters with disabilities to leave blinds up overnight on state-owned land did not make it to spring hearings this time around. Will be proposed next spring. Natural Resources Board (NRB) will discuss allowing ABC permit holder to participate statewide during the Youth Hunt.
- Montello Fishing Barricade was put in pathway and blocking access to recently
  added universally accessible fishing pier. Therefore, wheelchair users are now
  blocked off from pier access. The village/city of Montello needs to be contacted to
  rectify this. This is not DNR property, but it is believed that DNR stewardship funds
  were used for the pier.

# RightHear at Heritage Hill

Tentative launch date of July 22<sup>nd</sup>. Save the date, but not set in stone yet. Calvin will send out an invite when more is known, and system is up and running.
