- On March 25th a letter was sent to the Governor and legislature urging them to reconsider the reduction or elimination of funding from the EMA for recycling grants, UW SHWEC & UW solid waste research.
- On May 1st, a memo was sent to members of the Joint Finance Committee (JCF) urging them to preserve recycling and waste reduction funding.

May 6, 2015 – WDNR Madison

The council discussed other potential sources of funding to support recycling at the municipal and county level including:

- The advancement of product stewardship and extended producer responsibility for individual commodities,
- Urging the legislature to allocate tipping fees to recycling programs as intended, and
- The potential for WEDC funds to be used to help support recycling growth industries as well as develop recycling businesses in Wisconsin using Wisconsin feedstocks.

On a broader note, the council recognized that the general public would benefit from clarification on many recycling issues, and opportunities to provide more information and education should be explored. Topics discussed included:

- Developing a greater understanding of the association between recycling and business including investments, jobs and markets in Wisconsin,
- Shifting the view of recycling as a municipal service to a business opportunity where a

- marketplace for Wisconsin feedstocks could be developed,
- Exploration of how a decline in legislative support of recycling could result in less investment in Wisconsin recycling businesses,
- Developing a greater understanding that the reduction in recycling grant funds is not a tax savings but a fund diversion to non-waste management activities, and
- Developing a greater understanding of household costs for solid waste and recycling, sources of funding, and state funding trends.

The council discussed future priorities to develop and support recycling policy in Wisconsin. These included:

- Increase external communications and further develop the presence of the council in an advisory role.
- Develop new relationships while maintaining its existing ones.
- Provide updates and information to legislators through standing appointments.
- Provide a biannual Council on Recycling report.
- Develop policy to increase C&D recovery.
- Focus on design of recyclable products and packaging.
- Provide educational tours sponsored by the council.

September 22, 2015 - WDNR Madison

Member suggestions for priority issues included:

- Maintain plastics subcommittee updates as a standing item on the agenda
- Study product stewardship and extended producer responsibility opportunities for a variety of materials including paint, batteries etc.
- Study C&D recycling opportunities and barriers
- Explore zero waste concept and initiatives
- Address material issues such as glass
- Develop and maintain recycling industry and MRF market connections
- Restore funding to RUs
- Address policy to ensure that fees collected for recycling are appropriated to recycling activities
- Request full council membership including a representative from the public sector to work with business, industry and non-profit representatives
- Collaborate with other organizations and agencies to expand recycling in Wisconsin and address the barriers and challenges to C&D, glass, food and paint recycling

November 4, 2015 - WDNR Madison

Presentation from Plastic Subgroups – Agricultural Plastics, Rigid Plastics, WRAP (film), Plastic Bottles

Council members discussed future priority issues:

- 1. Plastics The council will continue its work on plastics recycling. Joe and Heidi will co-chair the plastics subcommittee. This will involve helping define the goals of each of the four work groups, providing support and inviting speakers to update the council.
- 2. Education The council should explore how to effectively inform and educate Wisconsin's citizens and elected officials on recycling related issues. This should include information on

- what, where and how to recycle as well as a better understanding of how recycling affects citizens individually and the state as a whole. What can the council do to achieve this?
- 3. Electronics— The council should review the DNR's annual E-Cycle report (12/01/2015) to determine any necessary actions.
- 4. Product Stewardship Representatives from PaintCare, Call2Recycle and other product stewardship organization have attended meetings to educate the council on their approaches to managing various products. The council should be knowledgeable on these topics and well positioned to support legislation in Wisconsin when appropriate. AROW has indicated an interest in helping to achieve this.
- 5. Construction and Demolition As one of the largest components of landfills, the council should explore economically feasible options to increase C&D recycling.
- 6. Organics The awareness of the benefits of organics diversion from landfills is increasing and communities are becoming more aware of their options including large and small scale composting and anaerobic/aerobic digesters. How can the council work to increase organics diversion?
- 7. Funding Recycling The council should understand how recycling is funded and how the funds are being used. How are RUs impacted by the grant determination and the funds available? The council should understand the budget cycle and determine how to work within the timeframe to restore funding to RUs.

 - 1. More information was needed to consider any efforts in the C&D recycling sector. The Waste and Materials Management Study Group (WMMSG) is considering this as an area of focus and may be a source of collaboration for the council. Duplication of efforts is a concern.
 - 2. Understanding the startup, licensing and operation of organics collection, transportation and composting operations could provide value in facilitating new businesses and

- increase organics diversion. Council members agreed to begin identifying issues facing organic waste diversion efforts at the July meeting.
- 3. Developing a list and profile of all WI based companies in the waste diversion and recycling sector could be a valuable resource and help define the economic value of recycling in Wisconsin. The status of the existing markets directory needs to be determined before any action is taken.
- 4. Product stewardship efforts in paint should be researched and the general consensus is that existing industry support and facilitation through PaintCare make this a viable option for Wisconsin. Council members should familiarize themselves with PaintCare and product stewardship before the next meeting.

Discussion of Priority Issues and Ranking

Joe Van Rossum, DNR provided a brief summary of methods the council has used to explore and address priority issues in the past including the following:

Engagement of stakeholders to facilitate connections and conversation about issues. This may or may not result in further action but serves to develop a network for future activities. Examples of this include the councils work on adhesives, paint recycling (PaintCare), and battery recycling (Call2Recycle).

Workgroups can be organized to gather information and generate reports. Examples include the plastic film and used oil filters workgroups which resulted in a pilot study and eventual implementation of the WRAP program in Wisconsin, and the generation of draft legislation on oil filters.

Tours can be provided to educate council members and the general public on products and facilities of interest.

Advocacy can be an effective tool and can include testimony, letters and in person meetings. The council has advocated alone and in conjunction with other organizations such as AROW, SWANA and WCSWMA. Most recently, this council has advocated by letter to restore recycling funding and staff the council.

Van Rossum then led council members through a process of reflection and analysis using the "What? So What? Now What?" method for the highest ranked priority item "Recycling Markets". The results are listed below:

- 2. Information about market conditions (official board of markets)
- 3. Regional (Wisconsin) and national/global differences in markets
- 4. Markets for single stream materials (plastics, metals, paper/OCC etc.)
- 5. Driver: need an end use

- 7. Driving costs of municipal recycling programs
- 8. Driver of prices (sorting by grade)
- 9. Reduction of virgin material use
