Rule Information:

The primary objective of the proposed rule is to include new federal requirements from the 2021 Lead and Copper Rule Revisions (LCRR) and the 2024 Lead and Copper Rule Improvements (LCRI). The rule proposes changes to the lead and copper drinking water regulations for community and non-transient non-community water systems. The proposed rule includes changes to lead and copper sampling, service line inventory and replacement, corrosion control treatment, and public education and outreach. The proposed changes are designed to protect the public from lead health impacts and ensure state regulations are consistent with federal regulations.

Initial Regulatory Flexibility Analysis:

Some small businesses are subject to the federal LCRR and LCRI and corresponding state rule. The proposed rule regulates non-transient non-community water systems (NTNCWSs), which can include places like factories, farms, schools, and other places of work, and other-than-municipal community water systems (OTMs), such as apartment complexes and mobile home parks.

This state rulemaking will have minimal implementation and compliance costs beyond the baseline costs that are already required by federal law. The DNR estimated in the proposed rule's economic impact analysis (EIA) that 70% of NTNCWSs' and OTMs' compliance cost can be assumed to be a small business cost. The annual statewide cost for these small businesses, combined, is expected to be \$7,465.

Due to federal primacy requirements, the department is unable to consider any less stringent requirements. However, wherever possible, the department simplified and clarified the federal requirements in the proposed rule. The proposed rule and federal rules include a small-system flexibility section that will allow small businesses more flexibility in their rule compliance pathway.
