

## Notice of Preliminary Hearing on Statement of Scope

The Department of Natural Resources announces that it will hold a preliminary public hearing on Statement of Scope SS 058-23 relating to Lake Superior cisco and lake trout quotas. In accordance with s. 227.136, Wis. Stats., the DNR is seeking public comment and feedback on Statement of Scope SS 058-23 at the time and virtual location shown below.

**Rule Information:** This is a statement of scope for proposed emergency and permanent rules; no rule has yet been drafted. The rules drafted under this statement of scope would update lake trout and cisco quotas based on the most recent data collection cycle, and may also revise other regulations relating to Lake Superior commercial fish species, including size and bag limits, season dates, allowable gear, and fishing zones. The rules may also create a mechanism for more efficient updates to quotas and associated regulations. No specific proposals relating to these regulations have yet been developed.
