Rule Information: Chapter NR 45, Wis. Adm. Code, encompasses department property management regulations that apply to a variety of lands, including the state park system, state forests, state wildlife areas, state fishery areas, and state natural areas. Regulations contained in ch. NR 45 address the protection of public safety, health and welfare, property usership including allowable recreational activities, resource management and conservation, and special feature preservation on department-managed lands. In addition, multiple other chapters of administrative code contain provisions that relate to department-managed properties or interact with provisions in ch. NR 45, so this rule makes minor changes in a subset of those chapters as well.

This rule will not substantively affect existing policy, and would have minimal, if any, impact on visitors to department-managed lands.
