NR 1 and 45, relating to minor changes to DNR property management regulations (the 2025 property management housekeeping rule), at the time and place shown below. Rule Information: The department is holding a second public hearing on FWP-22-24 (CR 25-088) to address technical difficulties that occurred during the first hearing on Jan. 12, 2026. Based on public comments received during the initial comment period from Dec. 8, 2025, to Jan. 12, 2026, the department intends to remove SECTIONS 4 and 6 (climbing-related definitions) of the rule from the final version that will go to the Natural Resources Board for consideration. The department intends to address SECTIONS 4 and 6 of the current rule and climbing provisions during a future rulemaking effort.

Chapter NR 45, Wis. Adm. Code, encompasses department property management regulations that apply to a variety of lands, including the state park system, state forests, state wildlife areas, state fishery areas, and state natural areas. Regulations contained in ch. NR 45 address the protection of public safety, health and welfare, property usership including allowable recreational activities, resource management and conservation, and special feature preservation on department-managed lands. In addition, multiple other chapters of administrative code contain provisions that relate to department-managed properties or interact with provisions in ch. NR 45, so this rule makes minor changes in a subset of those chapters as well.

This rule is not intended to substantively affect existing policy, and would have minimal, if any, impact on visitors to department-managed lands.
