Rule Information: Current rules establish provisions for a variety of activities involving Wisconsin's native amphibians and reptiles, including harvest, live take, possession, propagation, purchase, sale, trade, exhibition, rehabilitation, stocking and release. However, the majority of these rules have not been updated since the 1990s. Additionally, the department has heard feedback that these rules are difficult to interpret and enforce. These rules will be updated to provide better clarity to the public while better protecting the amphibians and reptiles. Poaching, harassment, increased collection pressure and wildlife trafficking are negatively impacting amphibian and reptile populations throughout North America and around the world. In addition, many emerging diseases are also causing increased pressure on amphibian and reptile populations
