**Rule Information:** This rule creates new harvest zones for sharp-tailed grouse. It also updates rule language to acknowledge that sharp-tailed grouse applications are submitted electronically and not through the mail. Finally, this rule updates the metrics used to establish sharp-tailed grouse quotas. These metrics are consistent with existing department policy because they are similar to those found in the new sharp-tailed grouse management plan which was approved by the Natural Resource Board in the spring of 2024.
