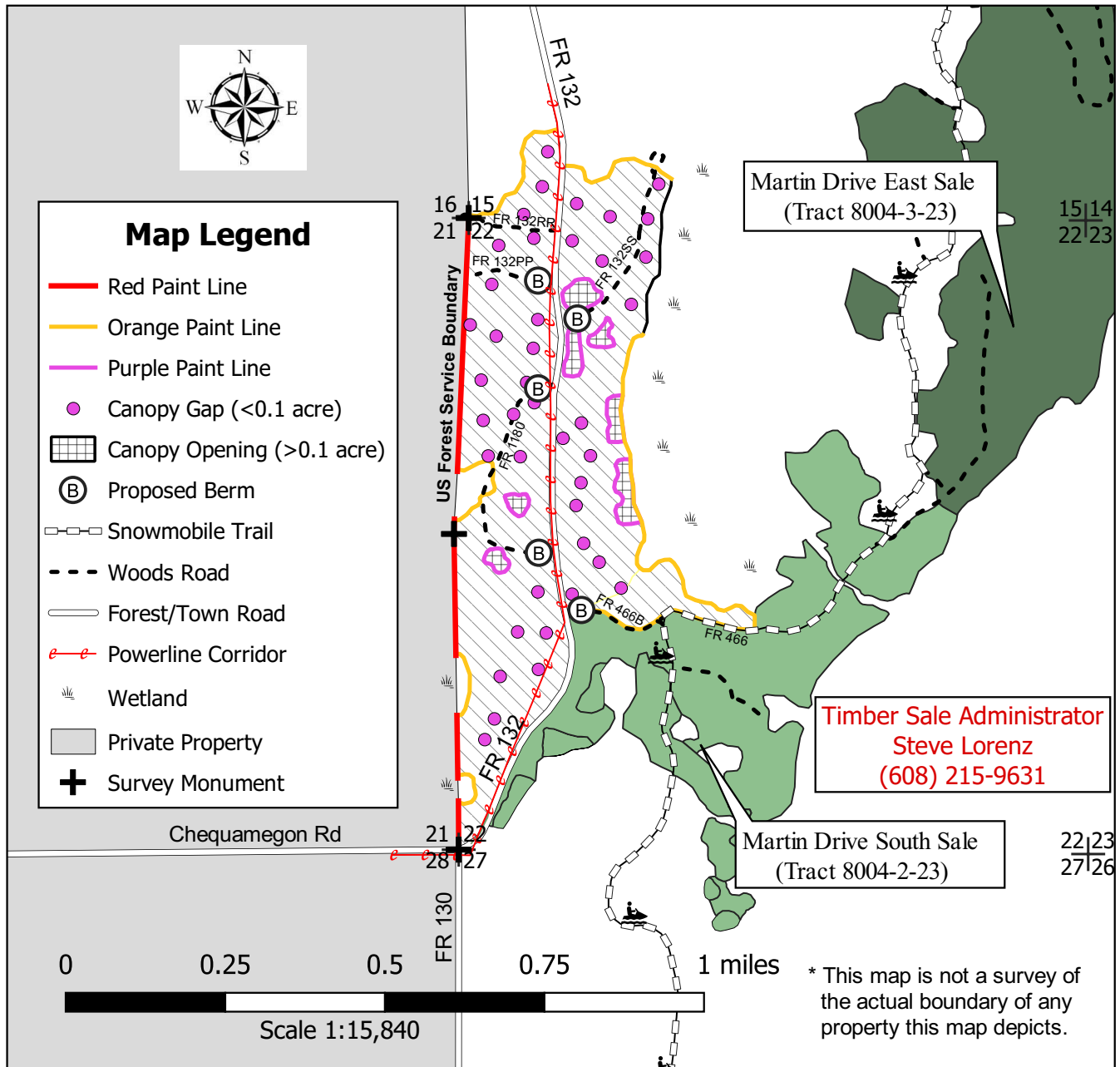
Hardwood Selection Area (142 acres)

Area bounded by orange paint, red paint, FR 132, and natural swamp/bog edge.
 Harvest: 1) blue marked trees; and all 1-stick and larger: 2) aspen, 3) balsam fir, and 4) ironwood.



Canopy Gaps and Openings (11 acres)

Area bounded by purple paint (V-shaped marks face into gaps/openings; dots face outside).
 Harvest all trees greater than 1" d.b.h. except: 1) pine, 2) hemlock, 3) cedar, 4) butternut,
 5) oak saplings less than 5" d.b.h., and 6) purple marked trees.

¹Mixed Hardwood Pulp includes 45% hard maple, 35% ash, 15% red maple, and 5% red oak (with small amounts of ironwood and other species).

²Mixed Hardwood Saw includes 7 MBF hard maple, 4 MBF basswood, 2 MBF red maple, and 1 MBF white birch.

Other species not mentioned will be charged at the Mixed Hardwood Pulp or Saw price, accordingly.

- 1) Bids must meet or exceed the total minimum acceptable bid of **\$28,205.00**.
- 2) Each species/product must be bid on (per ton or MBF).
- 3) A bid will be rejected if any individual species/product bid is \$0.
- 4) Cordwood weight conversion factors are as follows:
Mixed Hardwood = 2.400 Aspen = 2.250 Balsam Fir = 2.125 Basswood = 1.925

Paint Color Scheme:

- **Blue:** Trees to be harvested. **Cut all blue marked trees.**
- **Orange:** Sale/stand boundary and reserve/leave trees. **Do not cut any orange marked trees.**
- **Red:** Property boundary trees. **Do not cut any red marked trees or cross onto private property.**
- **Purple:** Canopy gap boundary and reserve/leave trees. **Do not cut any purple marked trees.**

Seasonal Restrictions:

- Harvesting operations are limited to **frozen ground conditions only**.
- Hauling on snowmobile trail is prohibited on Christmas and New Year's holidays (from noon on December 23rd to 4 a.m. January 2nd), and all other weekends (from noon Friday to 4 a.m. Monday) when trails are open (only a small portion of the snowmobile trail borders the sale area so this may not be applicable).

Harvest Requirements:

- Contract ending date will be **June 30, 2026** (allowing 3 winter seasons to complete).
- Harvest boundaries include orange paint line, red paint line, Forest Road 132 and natural swamp/bog edge.
- No machine operation allowed outside of orange or red boundary paint line, or in adjacent swamp/bog areas.
- The harvesting of any portion of a tree that lies outside the physical ownership of the Forest Service will not be allowed. Trees lying across the property line must be bucked at the ownership line and all portions of the tree that reside on the private side of the line must be left in place. Conversely, the remaining portion of the tree that lies within the physical ownership of the Forest Service may be harvested and utilized.
- No bond is required with bid on this timber sale. A performance bond of 15% of the total bid value will be required within 6 weeks of announcement of successful bidder.
- Sale will be mill scale using a 30-day billing period.
- Equipment must be cleaned and inspected by DNR staff before entering and leaving the sale area to prevent the introduction/spread of invasive species.

Slash Requirements:

- A 10-foot slash removal zone shall be applied to either side of Forest Road 132 as well as adjacent to private property (red paint line) boundaries.
- Slash height within 100 feet of Forest Road 132 shall be less than 24” in height.
- Slash height within 100 feet of snowmobile trail shall be less than 36” in height.
- Do not pile slash within riparian or other wetland areas.

Road/Trail Requirements:

- DOT approved signage is required to be placed on Forest Road 132 during harvest and hauling operations for safety reasons. Signage is also required along the snowmobile trail when equipment is in the vicinity of the trail.
- If decking wood on Forest Road 132, written permission must be obtained from the Town of Emery. Decking along woods roads is preferred for safety and local access concerns.
- Keep snowmobile trail free and clear of logging debris. Maintain at least 4” of compacted snow (conditions permitting) on trail surface when open to public use.
- Forwarding is allowed on snowmobile trail; however, no skidding is allowed on snowmobile trail.

Additional Requirements:

- **NO SALE MAY BEGIN WITHOUT PRIOR NOTIFICATION AND AN ON-SITE MEETING WITH A WISCONSIN DNR SALE ADMINISTRATOR.**
- Keep all logging debris and machine operations within sale boundaries.
- Leave all standing snag and cull/den trees that do not pose a safety hazard. If needed to remove as a safety precaution, cut and leave lay on the ground.
- New temporary roads, stubs, or turn-arounds will need approval by the timber sale administrator and may require berms/slash.
- Temporary Roads shall have the road base constructed to a width of 12 feet or narrower, and with vegetative clearing of trees and brush not to exceed a width of 25 feet. Exceptions to the 12-foot maximum width of the road base may be granted by the sale administrator for operational reasons.
- If roads that are marked with **Proposed Berm** symbol are utilized, they must be closed with a logging debris berm. Do not dig a depression that will collect and hold water when constructing berms.
 - **Proposed Berm** shall be constructed using logging debris which includes any combination of dirt mixed with rocks, stumps, logs, root-wads, and/or slash.
 - **Proposed Berm** shall be constructed without creating a defined trench.
 - **Proposed Berm** shall be at least 4-5 feet in height from ground level.
- All road maintenance and post-harvest rehabilitation will be the purchaser’s responsibility. A sample contract including road maintenance specifications can be obtained upon request.
