GOOD NEIGHBOR AGREEMENT SUPPLEMENTAL PROJECT AGREEMENT To MASTER GOOD NEIGHBOR AGREEMENT #15-GN-11091300-108 BETWEEN THE STATE OF WISCONSIN, DEPARTMENT OF NATURAL RESOURCES AND THE USDA, FOREST SERVICE, REGION 09 CHEQUAMEGON-NICOLET NATIONAL FOREST

This Supplemental Project Agreement (SPA) is hereby made and entered into by and between the Wisconsin Department of Natural Resources hereinafter referred to as "the State," and the USDA, Forest Service, Region 09, Chequamegon-Nicolet National Forest, hereinafter referred to as the "U.S. Forest Service," under the authority of the Agricultural Act of 2014, Pub. L. 113-79, section 8206, (Good Neighbor Authority), and Wis. Stats. ss. 20.370 (1) (cz), 20.370 (1) (mv) and 28.15, and specified under the provisions of Master Good Neighbor Agreement #15-GN-11091300-108. The CFDA for this agreement is 10.691.

Title: Good Neighbor Supplemental Project Agreement for Forest Restoration Services Authorized Activities: Only authorized forest, rangeland, and watershed restoration services are allowed under this SPA which includes activities to treat insect and disease infected trees; activities to reduce hazardous fuels; and any other activities to restore or improve forest, rangeland, and watershed health, including fish, and wildlife habitat. Services not allowed under this SPA includes construction, reconstruction, repair, or restoration of paved or permanent roads or parking areas and construction, alteration, repair, or replacement of public buildings or works; as well as projects in wilderness areas, wilderness study areas, and lands where removal of vegetation is prohibited or restricted. Road maintenance and construction and decommissioning of temporary roads necessary to implement restoration or improvement projects are allowed. Timber Sales may be conducted on National Forest System lands as approved in Appendix D of this SPA.

I. GENERAL PROJECT DESCRIPTION

The State of Wisconsin and the USDA Forest Service enter into this agreement as a cooperative effort to perform forest, rangeland, and watershed restoration services including activities on and off National Forest lands to treat insect and disease infected trees; activities to reduce hazardous fuels; and any other activities to restore or improve forest, rangeland, and watershed health, including fish, and wildlife habitat. This agreement covers the entire suite of activities that meet the goals and objectives identified in the Chequamegon-Nicolet Land and Resource Management Plan and that are authorized under Good Neighbor Authority.

In consideration of the above premises, the parties agree as follows:

II. RESPONSIBILITIES:

- A. The State shall:
 - 1. Collaborate with the Forest Service in development of the Scope of Work (SOW) as described in C1 below.
 - 2. Perform the activities described in the SOW, attached as Appendix A, and the Timber Removal Plan, Appendix D, if attached. As appropriate, work will comply with requirements of the National Environmental Policy Act (NEPA) decision as well as provided or approved silvicultural prescriptions and timber marking guides. The State shall utilize the information provided by the Forest Service to comply with Federal regulations including the protection of federal resources, permitted uses and forest product accountability.
 - 3. <u>FINANCIAL STATUS REPORTING</u>. A Federal Financial Report, form SF-425 (and Federal Financial Report Attachment, SF-425A, if required for reporting multiple awards), must be submitted ANNUALLY. These reports are due 30 days after the reporting period ending June 30. The final SF-425 (and SF-425A, if applicable) must be submitted either with the final payment request or no later than 90 days from the expiration date of the Good Neighbor Agreement. These forms may be found at www.whitehouse.gov/omb/grants_forms.
 - 4. Report timber sales completed quarterly, including total harvest volumes, to the Forest Service.
 - 5. Remit payment of the bill for collection, for the approved rate for timber harvested within 30 days of receipt of bill for collection. Payments should be sent to the address shown on the bill for collection.
 - 6. Monitor the use of Program Income and report Program Income values and use to the Forest Service at least annually. The State must receive prior approval from the Forest Service for activities in which the state will require reimbursement of funds from the Forest Service, before performing reimbursable activities.
- B. The U.S. Forest Service shall:
 - 1. Collaborate with the State in development of the Scope of Work as described in C1 below.
 - 2. Perform the activities described in the Scope of Work, attached as Appendix A, and the Timber Removal Plan, Appendix D, if attached. The Forest Service must be involved in the development and implementation of any work performed on National Forest System (NFS) lands.

- 3. Complete all necessary National Environmental Policy Act (NEPA) requirements. Any decision required to be made under NEPA with respect to any authorized restoration services to be provided under this agreement on NFS lands shall not be delegated to the State.
- 4. Provide information to the State, such as NEPA mitigation or requirements; silviculture prescriptions and marking guides; and locations of protected resources as necessary to comply with federal law, regulation, and policy.
- 5. Ensure appropriate property boundary line determination and designation, if applicable, is completed prior to implementation of project activities.
- 6. Bill the State quarterly for all timber reported harvested by the State. Payment is due within 30 days of the date of billing. Bill for Collection will be sent to

- 7. Consistent with all sales of NFS timber, the Forest Service shall provide for the review of sale preparation work by competent, experienced specialists. The review must determine that sale preparation followed the provided or approved silvicultural prescription and standard operating procedures, as agreed to in Appendix F, and other resource protection requirements or guidance for sale preparation. The review must include on-the-ground review of quality and compliance with environmental analysis for a sample of the sales as determined in the Scope of Work. See Appendix F item XV.
- C. It Is Mutually Understood and Agreed By And Between The Parties That:
 - 1. JOINT SCOPE OF WORK (SOW). Both parties will collaborate in the development of a SOW, which will be incorporated and made a part of this agreement. At a minimum, the SOW must clearly provide a plan of operations and quality control for project work, identify activities to be performed, and the responsible party. The funding for those activities will correspond to and be reflected in the financial plan. A timeline for the work activities should be included to serve as a monitoring tool for both parties, and to help ensure completion of the work within the period of performance of the SOW. The work described in the SOW must reflect the activities approved in the applicable National Environmental Policy Act (NEPA) document and any mitigation activities identified therein.
 - 2. <u>AVAILABILITY FOR CONSULTATION</u>. Both parties will make themselves available at mutually agreeable times, for continuing consultation to discuss the

conditions covered by this agreement and agree to actions essential to fulfill its purposes.

3. <u>ADVANCE AND REIMBURSABLE PAYMENTS</u>. Payments are approved under this Good Neighbor Agreement. Only costs for those project activities approved in (1) the initial agreement, or (2) modifications thereto, are allowable. Requests for payment must be submitted on Standard Form 270 (SF-270), Request for Advance or Reimbursement, and must be submitted no more than monthly. In order to approve a Request for Advance Payment or Reimbursement, the Forest Service shall review such requests to ensure advances or payments for reimbursement are in compliance and otherwise consistent with OMB, USDA, and Forest Service regulations.

Advance payments must not exceed the minimum amount needed or no more than is needed for a 30-day period, whichever is less. If the State receives an advance payment and subsequently requests an advance or reimbursement payment, then the request must clearly demonstrate that the previously advanced funds have been fully expended before the Forest Service can approve the request for payment. Any funds advanced, but not spent, upon expiration of this agreement must be returned to the Forest Service.

4. <u>OVERPAYMENT</u>. Any funds paid to the State in excess of the amount entitled under the terms and conditions of this agreement constitute a debt to the Federal Government. The following must also be considered as a debt or debts owed by the State to the U.S. Forest Service:

- Any royalties or other special classes of Program Income which, under the provisions of the agreement, are required to be returned.

If this debt is not paid according to the terms of the bill for collection issued for the overpayment, the U.S. Forest Service may reduce the debt by:

- a. Making an administrative offset against other requests for reimbursement.
- b.Withholding advance payments otherwise due to the State.
- c. Taking other action permitted by statute (31 U.S.C. 3716 and 7 CFR, Part 3, Subpart B).

Except as otherwise provided by law, the U.S. Forest Service may charge interest on an overdue debt.

5. <u>NON-FEDERAL STATUS FOR STATE PARTICIPANT LIABILITY</u>. The State agree(s) that any of their employees, volunteers, sub-recipients, contractors, and participants shall not be deemed to be Federal employees for any purposes including Chapter 171 of Title 28, United States Code (Federal Tort Claims Act) and Chapter 81 of Title 5, United States Code (OWCP), as the State hereby willingly agrees to assume these responsibilities to the extent allowed by state law.

Further, the State shall provide any necessary training to their employees, volunteers, sub-recipients, contractors, and participants to ensure that such personnel are capable of performing tasks to be completed. The State shall also supervise and direct the work of its employees, volunteers, and participants performing under this SPA.

- 6. <u>CONTRACT REQUIREMENTS</u>. When procuring property and services under this Master Agreement, the State must follow the same policies and procedures it uses for procurements from its non- Federal funds, as described in 2 CFR 200.317.
- <u>MODIFICATIONS</u>. Modifications within the scope of this agreement must be made by mutual consent of the parties, by the issuance of a written modification signed and dated by all properly authorized, signatory officials, prior to any changes being performed. Requests for modification should be made, in writing, at least 30 days prior to implementation of the requested change. The U.S. Forest Service is not obligated to fund any changes not properly approved in advance.
- 8. <u>PROGRAM PERFORMANCE REPORTS.</u> The parties to this agreement shall monitor the performance of the Good Neighbor Agreement activities to ensure that performance goals are being achieved.

Performance reports shall contain information on the following:

- A comparison of actual accomplishments to the goals established for the period. The output of the project can be readily expressed in numbers, a computation of the cost per unit of output, if applicable,

- Reason(s) for delay if established goals were not met.

The State shall submit annual performance reports. These reports are due 30 days after the reporting period ending June 30. The final performance report shall be submitted either with the State's final payment request, or separately, but not later than 90 days from the expiration date of the Good Neighbor Agreement.

- 9. <u>COORDINATION OF LAW ENFORCEMENT</u>. Either party to this agreement shall provide to the other party, any and all reports of violations of law cited within the project area or otherwise associated with the activities of the agreement.
- 10. <u>BUILDING AND COMPUTER ACCESS BY NON-FOREST SERVICE</u> <u>PERSONNEL</u>. The State may be granted access to U.S. Forest Service facilities and/or computer systems to accomplish work described in the Operating Plan or Scope of Work. All non-government employees with unescorted access to U.S. Forest Service facilities and computer systems must have background checks following the procedures established by USDA Directives 3800 series. Those granted computer access must fulfill all U.S. Forest Service requirements for mandatory security awareness and role-based advance security training, and sign all applicable U.S. Forest Service statements of responsibilities.
- 11. <u>PROPERTY IMPROVEMENTS</u>. Improvements placed on National Forest System land at the direction or with approval of the Forest Service become property of the United States. These improvements will be subject to the same regulations and administration of the Forest Service as would other National Forest improvements of a similar nature. No part of this Master Agreement entitles the State to any interest in the improvements, other than the right to use and enjoy them under applicable Forest Service regulations.
- 12. <u>USE OF GOVERNMENT OWNED VEHICLES</u>. U.S. Forest Service vehicles may be used by the State employees or State sub-awardees or State sub-contractors, including county forest employees and contracted consulting foresters, for official U.S. Forest Service business only accordance with FSH 7109.19, chapter 60, the requirements established by the region in which performance of this agreement takes place, and the terms of this agreement. It is not the intent to provide the State the use of U.S. Forest Service vehicles. The occasional use of U.S. Forest Service vehicles for particular activities, such as joint inter-disciplinary review, will be mutually agreed upon.
- 13. <u>FUNDING EQUIPMENT</u>. Federal funding under this agreement is not available for reimbursement of the State's purchase of equipment. Equipment is defined as

having a fair market value of \$5,000 or more per unit and a useful life of over 1 year.

14. <u>AGREEMENT CLOSE-OUT</u>. Within 90 days after expiration or notice of termination the parties shall close out the agreement.

Any unobligated balance of cash advanced to the State must be immediately refunded to the U.S. Forest Service, including any interest earned in accordance with 2 CFR 200.343.

Within a maximum of 90 days following the date of expiration or termination of this agreement, all financial performance and related reports required by the terms of the agreement must be submitted to the U.S. Forest Service by the State.

If this agreement is closed out without audit, the U.S. Forest Service reserves the right to disallow and recover an appropriate amount after fully considering any recommended disallowances resulting from an audit which may be conducted later.

- 15. <u>TERMINATION BY MUTUAL AGREEMENT</u>. This agreement may be terminated, in whole or part, as follows:
 - a. When the U.S. Forest Service and the State agree upon the termination conditions, including the effective date and, in the case of partial termination, the portion to be terminated.
 - b. By 30 days written notification by either party setting forth the reasons for termination, effective date, and in the case of partial termination, the portion to be terminated. If the U.S. Forest Service decides that the remaining portion of the agreement will not accomplish the purposes for which the agreement was made, the U.S. Forest Service may terminate the agreement in its entirety.

Upon termination of an agreement, the State shall not incur any new obligations for the terminated portion of the agreement after the effective date, and shall cancel as many outstanding obligations as possible. The U.S. Forest Service shall allow full credit to the State for the U.S. Forest Service share that cannot be cancelled and were properly incurred by the State up to the effective date of the termination. Excess funds must be refunded within 60 days after the effective date of termination.

16. <u>ADVANCE PAYMENT FOR TIMBER.</u> Advance payment to the U.S. Forest Service for timber harvested is not required under this Good Neighbor Agreement. 36 CFR 223.34 requires that all sales contracts provide for payment or satisfactory payment guarantee in advance of harvest. Good Neighbor Agreements are not sales contracts; therefore, the U.S. Forest Service will accept this signed agreement as documentation that the State stands behind the agreement with the full faith and credit of the State. I. Project description and agreed-to activities:

The State of Wisconsin, Department of Natural Resources (the State) and the USDA Forest Service, Chequamegon-Nicolet National Forest (U.S. Forest Service) enter into this agreement as a cooperative effort to perform forest, rangeland, and watershed restoration services including activities on and off National Forest lands to treat insect and disease infected trees; activities to reduce hazardous fuels; and any other activities to restore or improve forest, rangeland, and watershed health, including fish, and wildlife habitat. This agreement covers the entire suite of activities that meet the goals and objectives identified in the Chequamegon-Nicolet Land and Resource Management Plan and that are authorized under Good Neighbor Authority.

This agreement is intended to cover a ten year period in total. However, the specific project areas and treatment activities shall be identified on an annual basis and consequently this agreement shall be amended annually to incorporate additions and subtractions from the list of agreed activities. During years one through three the primary focus of this agreement will be on commercial timber harvest forest restoration projects; however, non-timber restoration projects may be considered based on available Program Income. During years four and five the focus will be on both timber and non-timber restoration projects. During years six through ten, the focus of the agreement will shift to implementing non-timber restoration projects and finishing previously contracted commercial timber forest restoration projects; however, additional timber projects may be included. The intent is to enter into another ten year agreement at approximately year five of this agreement, which will allow some of the timber sales established as part of this agreement to be sold and administered as part of the subsequent agreement.

The State of Wisconsin Department of Natural Resources (the State) and the Chequamegon-Nicolet National Forest (U.S. Forest Service) shall identify project areas and treatment activities on an annual basis, with an overall objective of accelerating the pace and scale of restoration activities on U.S. Forest Service lands. Through this acceleration of restoration activities the U.S. Forest Service will move closer to meeting the Goals and Objectives, along with associated outputs, as described in the 2004 Chequamegon-Nicolet National Forest Land and Resource Management Plan. The projects and treatments identified for approximately the next 12 month period will be identified specifically in Appendix C. Annually, the U.S. Forest Service and the State shall review project accomplishments, discuss current status of projects, identify future project areas and treatments for the next 12 month period, and shall formally amend this agreement, including Appendices B and C, to designate additional projects and treatments. Additionally, the U.S. Forest Service and the State may amend this agreement at any other time to address and respond to changing social or environmental conditions, including salvage treatments. II. Map and description of the project area, treatment activities, acres to be treated, timeline for work activities, and other agreed-to activities:

See Appendix C for a detailed list of projects and treatments, which includes the agreed treatment locations (maps or legal descriptions), treatment types, and approximate acres to be treated. The treatments identified in Appendix C are targeted to be established over the coming 12-18 months and administered and completed within approximately 48 months. When necessary, a more detailed timeline for activities may be identified in appendix C. Typically for commercial timber harvest projects the State will conduct the following phases: timber sale establishment (silvicultural prescription preparation, harvest boundary lay-out, timber designation, cruising, and contract development), timber sale administration (advertising, bid awarding, sale area inspections, scaling, billing, contract enforcement), and reforestation establishment as needed (site preparation, seeding, planting, release, and periodic regeneration monitoring). For restoration projects other than commercial timber harvests, Appendix C shall include treatment types, locations, and acres and shall identify specific tasks to be completed by the State and U.S. Forest Service.

III. Plan of operations & quality control plan:

The U.S. Forest Service and the State shall complete agreed to activities as outlined throughout this Good Neighbor Authority project agreement, including all appendices. Principal contacts identified in the supplemental project agreement shall communicate quarterly, at a minimum, to ensure operations are proceeding according to the agreement. Local U.S. Forest Service District contacts and local State field staff contacts will be identified to coordinate and communicate at the field level. Appendix C contains a detailed list of projects, treatments, and tasks to be completed by the State and U.S. Forest Service. The work to be completed by the State as part of this agreement shall be conducted by a combination of DNR staff, Wisconsin county forestry departments' staff, and private forestry consultants. Participating county forestry departments shall enter into separate agreements with the State as sub-awardees of or contractors for the State.

See Appendix F for the State Good Neighbor Project Operating Procedures. This document contains standard operating procedures for Good Neighbor Authority projects, including quality control measures. Appendix F shall supplement the existing State DNR policies and procedures for conducting project activities, including timber harvests, as established by law, administrative rule, DNR manual code, DNR handbooks (particularly the <u>Timber Sale Handbook 2461</u> and the <u>Public Forest Lands Handbook 2460.5</u>), and other DNR policy documents. Appendix F shall act to clarify existing procedures as they relate to Good Neighbor Authority projects and to establish new procedures, where existing procedures are insufficient to address Good Neighbor Authority projects. Appendix F shall be reviewed periodically, in conjunction with identification of additional project areas, and updated as needed to ensure all required policies and procedures are clearly addressed and agreed to.

IV. Specifications:

Typically for commercial timber harvest projects the State will conduct the following phases: timber sale establishment (silvicultural prescription preparation, harvest boundary lay-out, timber designation, cruising, and contract development), timber sale administration (advertising, bid awarding, sale area inspections, scaling, billing, contract enforcement), and reforestation establishment as needed (site preparation, seeding, planting, release, and periodic regeneration monitoring). When the timber harvest project phases described above will not all be conducted by the State, Appendix C shall specify the activities that will not be conducted by the State. For restoration projects other than commercial timber harvests, Appendix C shall include treatment types, locations, and acres and shall identify specific tasks to be completed by the State and U.S. Forest Service.

V. The State Shall:

- A. Collaboratively review NEPA approved projects with Forest Service to select restoration projects and treatments. Set up accounting systems and codes to charge preaward & future costs to and for maintaining Program Income. Work with the U.S. Forest Service to identify and select project areas and types of project work. Take U.S. Forest Service data and import into state programs, when possible and beneficial. Identify objectives. Generate maps or utilize maps generated by the U.S. Forest Service.
- B. Work collaboratively with Forest Service to prepare a Scope of Work (Appendix A), a financial plan (Appendix B), a list and maps of treatment activities (Appendix C), a timber removal plan (Appendix D), a GNA timber sale contract template (utilizing existing State DNR timber sale contract, Appendix E, and U.S. Forest Service Contract B & C provisions as necessary), and a plan of operations & quality control (Appendix F). Each of these shall be reviewed on an annual basis and updated as needed. Work with the U.S. Forest Service to include U.S. Forest Service policies addressed in GNA agreement, including Appendix E.
- C. Provide all silvicultural prescriptions prepared by the State to the U.S. Forest Service for approval prior to implementation. Review all silvicultural prescriptions provided by the U.S. Forest Service and request clarification if needed.
- D. Identify all post sale activities included in the final approved silvicultural prescription that will be accomplished by the State and communicate the results to the U.S. Forest Service.
- E. Layout sale area boundaries, mark trees to cut or leave, and cruise timber.
- F. Complete timber appraisal, create timber sale area map, complete draft timber sale contract. Provide timber sale contract along with other relevant documents from sale file to U.S. Forest Service for approval prior to soliciting bids. Notify principal local U.S. Forest Service contact of any significant contract modification, incorporating feedback as needed.

- G. Advertise sales in accordance with State procedures, solicit bids, and award contracts.
- H. Provide sold contract summary to U.S. Forest Service following each bid opening.
- I. Act on behalf of the U.S. Forest Service to implement authorized timber removal activities using State contracting procedures.
- J. Administer contracts, conduct periodic inspections of contract work, and collect timber sale proceeds from contractor.
- K. Provide a report of timber sales completed on a quarterly basis, including volume removed, to the U.S. Forest Service for the purpose of generating invoices for required payments to the U.S. Forest Service. The report will be provided within 30 days of the end of each quarter.
- L. Provide a report of other restoration services, including site preparation or reforestation activities, accomplished on a quarterly basis to the U.S. Forest Service for the purpose of maintaining forest inventory and upward reporting of Chequamegon-Nicolet N.F. accomplishments.
- M. Provide a summary report of project accomplishment on an annual basis following each state fiscal year to the U.S. Forest Service, to include timber removal volumes and acres for completed sales, Program Income, other non-timber project work accomplishments, and Federal Financial Report, form SF-425.
- N. Utilize available Program Income on approved activities prior to closeout of agreement. Check-in at year 5 and prepare for the next agreement. Review of activities to date. Closeout agreement at year 10 and comply with any audit procedures.

VI. The Forest Service Shall:

- A. Identify available NEPA approved projects. Identify road work needs on those NEPA approved projects which may be undertaken in part by the State. Work with State to identify project areas & treatments which the State is able to undertake. Grant Access to or transfer stand specific data to the State. Provide relevant NEPA decision documents & crosswalks and identify project specific measures needed to comply with the Forest Plan and NEPA decision. Identify objectives and/or treatments for project areas. Generate maps for use by State, if needed. Identify transportation system (roads) conditions & needs relative to the identified projects. Determine road closure needs. Identify mitigations and design features required in NEPA. Provide any additional project or treatment specific information that is needed to ensure successful project implementation.
- B. Work collaboratively with State to prepare a Scope of Work (Appendix A), a financial plan (Appendix B), a list and maps of treatment activities (Appendix C), a timber

removal plan (Appendix D), a GNA timber sale contract template (utilizing existing State DNR timber sale contract, Appendix E, and U.S. Forest Service Contract B & C provisions as necessary), and a plan of operations & quality control (Appendix F). Each of these shall be reviewed on an annual basis and updated as needed. Work with the State to include U.S. Forest Service policies addressed in GNA agreement, including Appendix E.

- C. Provide all silvicultural prescriptions prepared by the U.S. Forest Service to the State and provide clarification if requested by the State. Review all silvicultural prescriptions prepared by the State and communicate approval or request modifications within 15 business days of submission or provide written notification with justification and alternative completion timeframe. Ensure there is adequate detail in prescriptions to provide information that forester needs to set up the sale to meet management objectives and comply with Forest Plan and NEPA decision. Provide reference material in regards to supporting documentation.
- D. Provide access to U.S. Forest Service systems, and commensurate training, to the State for completing agreed to activities, when beneficial and mutually agreed to. (As stated in agreement provision II. C. 10 Building and Computer Access by Non Forest Service Personnel)
- E. Review and approve draft timber sale contract documents submitted by the State, including timber appraisal, timber sale area map, and a complete draft timber sale contract. Approve or request modification within 15 business days of submission or provide written notification with justification and alternative completion timeframe.
- F. Bill the State quarterly with 30 day payment term, based on quarterly reports received from the State, of timber sales completed, for agreed to and required U.S. Forest Service GNA Required Payments. U.S. Forest Service GNA Required Payments will include the greater of the Regional Forester established minimum rates (FSH2409.18; 45.7; \$1/ccf or \$3/ccf) or the combination of the cost of essential reforestation activities required within a sale area improvement (KV) plan not to be conducted by the State, agreed to non-essential activities to be performed by the U.S. Forest Service, and agreed to salvage sale funds, plus \$0.25/CCF. Additional deposits including 1.75% of State sold stumpage value for road maintenance will be collected and brush disposal may also be collected when agreed upon.
- G. Complete any required reporting of project accomplishments in U.S. Forest Service databases.
- H. Ensure project funds are utilized on approved activities prior to closeout of agreement. Check-in at year 5 and prepare for the next agreement. Review of activities to date. Closeout agreement at year 10 and comply with any audit procedures.
- I. Provide copy of sample contract with a sale area map to local Forest Service Law Enforcement personnel.

The financial plan budget breakdown is an estimate for the project period included. It is mutually understood and agreed that the final costs and revenues will vary and may exceed or fall short of estimated levels. Revenues and expenses will be monitored to ensure adequate Program Income has been or will be generated to complete project activities. Project activities identified in Appendix C may be delayed or dropped if Program Income is insufficient.

In addition to the GNA Required Payments that must be remitted to the U.S. Forest Service for timber harvested, the State shall remit additional deposits in the amount of 1.75% of State sold stumpage value for road maintenance. These funds shall be received and distributed by the U.S. Forest Service for the purpose of maintaining local road infrastructure, to compensate for the road use associated with Good Neighbor Authority projects.

Actual labor costs for work performed by the State staff or by County Forest staff will be accounted for using the actual hourly rate for each employee multiplied by the hours worked on approved GNA project activities, as reflected in Appendix B and Appendix C. These hourly rates may include overtime at the overtime pay rate that each employee is entitled to under their compensation plan or contract. A fringe rate shall be applied for all State and County Forest labor costs. For State employee labor, the fringe shall be at the rate annually approved by the federal government for the State of Wisconsin DNR. For county labor costs, counties shall be reimbursed for actual fringe costs per any subsequent agreement between the State and that county. Participating counties shall also be reimbursed for indirect (overhead) costs incurred by that county for all costs incurred at an indirect cost rate calculated and agreed to by the State and that county.

Actual contracting expenses may be based on an hourly, area, volume, or other basis.

An indirect cost rate shall be applied to the subtotal of all direct project costs at the rate annually approved by the federal government for the State of Wisconsin DNR.



IV. Cooperative fire agreement between Forest Service and State

Agreement up to date and on file. Reference Agreement Number: <u>12-F1-11091200-016</u>

V. Agreement on fire liability requirements outlined in the State's contract

Below is an excerpt from the State's GNA Timber Sale Contract Template:

- #14. FOREST FIRE PREVENTION. The Purchaser agrees to take reasonable precautions to prevent the starting and spreading of fires. Those precautions include, but are not limited to:
 - A. A minimum of one fully charged 5 pound or larger ABC fire extinguisher with a flexible spout shall be carried on each off-road logging vehicle.
 - B. All chainsaws and all non-turbocharged off-road logging equipment used in the operation shall be equipped with spark arrestors which have been approved by the U.S. Forest Service. Such arrestors may not be altered in any manner or removed and shall be properly maintained. (Information on approved arrestors may be obtained from the Seller.)

- C. If a fire occurs, the Purchaser agrees to promptly cooperate in the control and suppression of the fire.
- D. The Purchaser shall comply with requests regarding forest fire prevention and suppression made by the Seller and take all reasonable precautions to prevent, suppress and report forest fires. Those requests may include ceasing or modifying operations.
- E. The Purchaser shall be responsible for damage and forest fire suppression costs, including that provided in ss. 26.14 and 26.21, Wis. Stats., caused by their operation under this Contract.

VI. Agreement on respective roles and responsibilities to complete activities related to timber removal including (as appropriate):

A. Identification and management of transportation system, including:

- 1. The State shall require National Forest Systems roads to be maintained commensurate with use by timber purchasers to meet minimum standards for removing forest products.
- 2. No Specified Road Construction/Re-construction will occur under this agreement. Temporary roads are authorized to be constructed for the purpose of facilitating removal of Forest Products. The DNR shall agree with their Contract Purchasers to temporary road needs and locations, erosion control and closure measures per DNR GNA Timber Sale Contract.
- 3. U.S. Forest Service maintains responsibility for acquiring easements or use agreements of any private roads within Project Areas. The State agrees to pay agreed upon Road Maintenance Deposits in the amount of 1.75% of State sold stumpage value, in addition to minimum GNA Required Payments, to the U.S. Forest Service for the purposes of performing or fiscally assisting local road jurisdictions with deferred maintenance needs of public transportation facilities within the geographical boundaries of the Chequamegon-Nicolet National Forest.

B. Mapping and establishment of timber sale boundaries

- 1. The U.S. Forest Service shall establish all timber sale boundaries between national forest lands and other ownerships.
- 2. The State shall establish harvest area boundaries based on stand boundaries and NEPA decision provided by Forest Service, and accounting for actual stand conditions.
- 3. See Appendix F and DNR Timber Sale Handbook 2461.

C. Timber designation, cruise design, and cruising

1. See Appendix F and DNR Timber Sale Handbook 2461.

D. Timber Valuation Appraisal

- 1. The State shall appraise GNA Timber Sale volume utilizing DNR Timber Sale Handbook base stumpage rates for the County in which the timber sale is located or for an adjacent DNR State property. The State may incorporate GNA Timber Sale results into regularly scheduled updates of base rates. Appraisal documentation (DNR Form 2460-001) will be provided to the U.S. Forest Service with the Sample GNA contract prior to advertisement. Volume estimates provided by the State in units of measure of MBF (1,000 board feet) or cords will be converted by the U.S. Forest Service to CCF (100 cubic feet) with the following standard conversion factors. MBF*1.85=CCF (Sawtimber) Cords*.79=CCF (Pulpwood).
- 2. U.S. Forest Service will develop GNA Required Payment rates in \$/CCF, these are the greater of the Regional Forester established minimum rates (FSH 2409.18; 45.7; \$1/ccf or \$3/ccf) or the combination of essential reforestation activities required within a sale area improvement (KV) plan not to be conducted by the State, agreed to non-essential activities to be performed by the U.S. Forest Service, and agreed to salvage sale funds, plus \$0.25/CCF. Additional deposits of 1.75% of State sold stumpage value for road maintenance will be collected and brush disposal may also be collected when agreed upon. The rate and total collection per Sale will be provided to the DNR GNA Operations Leader with completion of the Sample GNA contract review prior to advertisement.
- 3. The GNA Required Payment rates, plus additional deposits will be the value to be remitted to the Forest Service. Any value received by the State in excess of the GNA required payment rates plus required deposits (road maintenance) will be retained as Program Income. Program Income will be expended prior to the termination date of this SPA on current or yet to be determined additional restoration activities.

E. Trust Fund Plans

- 1. Reforestation activities will be defined during the silvicultural prescription writing process and incorporated into final approved prescriptions. Agreement as to whether the State or the U.S. Forest Service will be responsible for completing the reforestation will be determined and communicated between parties upon the approval of the final prescription.
- 2. U.S. Forest Service shall incorporate those reforestation activities for which it will be responsible into the GNA Required Payment value to be remitted to the U.S. Forest Service.
- 3. Any other Trust Fund collections, such as non-required reforestation and Salvage Sale Fund, will be agreed to between the U.S. Forest Service and State prior to inclusion of the associated timber projects in Appendix C.

F. Billing and Payment Procedures

- 1. The State shall follow its existing procedures for billing of and payment from contractor. See Appendix F, the GNA Timber Sale Contract template, and DNR <u>Timber Sale Handbook 2461</u>.
- 2. The State shall hold the amount required to make the GNA Required Payment, to be remitted to the U.S. Forest Service, until the Bill for Collection is received. The portion of stumpage receipts received by the State for the GNA Required Payment is not Program Income, this portion of the receipts is considered a payment for timber to the National Forest System.
- 3. Upon quarterly notification from the State that individual GNA timber contracts have been closed and receipt of final volume tally, the U.S. Forest Service shall issue a Bill(s) for Collection to the State for a lump sum payment at the rate per CCF identified during the appraisal and contract review process multiplied by the final harvest volume. The Bill(s) for Collection will be mailed via US Postal Service to POC identified by the State for receipt.
- 4. The State shall remit payment to the Forest Service through Forest Service Lockbox, Electronic Funds Transfer, or Electronic Checking at the discretion of the State within 30 days of issuance of the Bill(s).
- 5. Upon receipt of payment from the State, the U.S. Forest Service shall generate and mail, via US Postal Service, a Timber Sale Statement of Account and Timber Sale Synopsis indicating the financial status of all State timber sales associated with the auction which the payment is associated with (e.g. GNA Auction Spring 2016). Information including current payments received, payments received to date, current quantity removed, and quantity removed to date are included in the Statement of Account. Additional information, including quantity remaining and value remaining, can further be extrapolated from the Statement of Account.

G. Developing and Approving Timber Sale contract (see Appendix E)

- 1. The State and U.S. Forest Service shall work collaboratively to prepare a GNA timber sale contract template (utilizing existing DNR timber sale contract, Appendix E, and Forest Service Contract B & C provisions as necessary).
- 2. The Forest Service shall review and approve draft timber sale contract documents submitted by the State, including timber appraisal, timber sale area map, and a complete draft timber sale contract. Approve draft contracts within 15 business days of submission or provide written notification with justification and alternative completion timeframe.

H. Timber Sale Administration, Log Load Accountability, and Coordination with Law Enforcement

- 1. The State shall conduct all timber sale administration in accordance with existing policies and procedures. See Appendix F, the GNA Timber Sale Contract template, and DNR <u>Timber Sale Handbook 2461</u>.
- 2. The State shall assume the lead role regarding investigation of violations of state or federal law pertaining to GNA Timber Contracts.
- 3. The State shall assume the lead role regarding enforcement of state law violations, and shall coordinate with the U.S. Forest Service for enforcement of violations of federal law.
- 4. The State shall inform the U.S. Forest Service local Project Contact of any observed law enforcement issues that they reasonably know are violations of state or federal law within GNA Project Areas such as those defined in Title 36 CFR Part 261 Subparts A and B. Examples include but are not limited to illegal timber harvest, property boundary issues, illegal special forest products harvesting, ATV or other illegal motorized access activities, illegal dumping, or abandoned property.
- 5. The U.S. Forest Service shall provide copies of GNA timber sale maps to local law enforcement upon completion of review of GNA Timber Sale Contracts.
- 6. U.S. Forest Service and State law enforcement personnel shall be notified of preoperations meetings for Good Neighbor projects. U.S. Forest Service notification by the State will be through direct communication, phone call or email, to US Forest Service Project Contact (District Ranger).
- 7. State and U.S. Forest Service Law Enforcement personnel shall share information, with the other party's respective contacts, regarding any investigations, citations or other law enforcement concerns involving Good Neighbor projects.

I. Final Acceptance and Close Out Process (Individual State Timber Sales)

- 1. The State shall provide reports quarterly of Timber Sales that have been closed for billing purposes as stated above. The reports will also include a sale synopsis with the following information:
 - a. Final volume removed
 - b. Final Inspection Report

- c. List of Substantial events or changes during sale administration such as unit boundary changes, changes to planned transportation access, contract breaches, disputes or claims.
- d. Prescribed reforestation activities completed through Timber Sale operations (e.g. aspen site prep or canopy gap cleaning).
- e. If a portion of the performance bond was retained to accomplish on the ground work after contract closure, such as road maintenance or erosion control, a follow up final inspection or other record of completion of these activities must also be provided.
- 2. The U.S. Forest Service shall issue a bill for the GNA Required Payment and associated deposits, if any. Upon receipt of payment U.S. Forest Service shall issue a sale synopsis recording the sale as accepted and report in required databases.

VII. Agreed and approved procedures and methods for achieving work products in number (VI.) above.

1. The agreed and approved procedures and methods for achieving work products are contained within other portions of this agreement including the Appendices.

I. Silvicultural Prescriptions:

- A. Approved timber stands identified by U.S. Forest Service that have cleared NEPA and meet GNA goals will be provided.
- B. U.S. Forest Service will develop and deliver training to the State for silvicultural plan writing and marking prescriptions.
- C. Silvicultural prescriptions, marking guidelines, and reforestation plans will be written by the State for all stands in each project site, unless provided by U.S. Forest Service.
- D. Chequamegon-Nicolet National Forest District Silviculturist, or designee, reviews and approves all plans.
- E. Approved silvicultural plans are forwarded to the Wisconsin DNR GNA Operations Leader for assignment of fieldwork.
- F. U.S. Forest Service will supply files for assigned project areas, including stand boundary maps and/or digital stand boundary information, other resource data including but not limited to stand reconnaissance data, threatened and endangered species, non-native invasive species, cultural resources, etc. . U.S. Forest Service threatened and endangered species and cultural resources data will be treated in a similar confidential fashion as the State treats its own threatened and endangered species and cultural resource data.

II. Timber Sale Boundaries Established (Project Design and Layout)

- A. General project boundaries are to be established by the State according to the GNA Project silvicultural plan.
- B. Flag external boundaries of the entire project; adjust and realign until finalized.
- C. If applicable, flag any interior unit or block boundaries; adjust and realign until finalized.
- D. If applicable, flag any special treatment areas, protection areas, exclusion zones, openings, and the like as described in silvicultural plan and marking guidelines.
- E. Paint all project boundary lines and where necessary include stand number, cutting unit number or other distinguishing marks using the appropriate paint color(s) as shown in Table 1.
- F. Traverse all stands of the sale project area. Develop a complete project area map, with specific acreage for each component as necessary, broken down by stand.

- G. Complete cutting notice (Form 2460) that describes the various attributes of the stands included in the sale listed by stand, including stand acreage.
- H. Maintain records of all cruise and traverse data and reports to be kept including GPS or azimuth-distance as part of the project file.
- I. Use Chequamegon-Nicolet National Forest stand numbers and names to identify sale areas.

III. Timber Marking

- A. Marking guidelines will be specified in silvicultural plans for each stand. A map of marking work area will be provided to markers. Projects will be marked using standard marking paint. Tracer paint will not be required.
- B. The primary methods for designating timber for harvest include marking the trees to be cut, or to be left in each stand and designation by species.
- C. Use a paint mark at or above DBH on both sides of trees and another mark below stump height for each cut tree or leave tree to be marked.
- D. Use the appropriate paint color(s) as shown in Table 1. Record colors used for timber marking of each sale component for inclusion in the timber sale contract.
- E. At completion of marking each stand, report stand number, paint colors used and acres to project manager.
- F. Notify Chequamegon-Nicolet National Forest District POC when marking/cruising is completed by timber sale prior to timber sale contract preparation.

IV. Volume Determination

U₽S

- A. Project stands require an estimate of tree volume to be removed (marked and/or designated), using the accepted method of sampling, variable radius plot cruising typically with 10 BAF. Cruise systems standards are detailed in the Wisconsin DNR Timber Sale Handbook, (TSH) chapter 24. Tally of volume while marking is done is also acceptable.
- B. Adhere to sampling error standards as appropriate to stand size and complexity as described in Timber Sale Handbook, Cruise Accuracy Guide, chapter 23.
- C. Maintain sufficient records to provide an audit trail of how the project contract volume was derived, from cruise plan to the final calculation of net volume entered in the sale prospectus and Timber Sale contract. At a minimum, maintain the following information:
 - 1. The original cruise design, including all changes to the original plan. Include the name of the person who prepared the plan or changes.
 - 2. Cruise implementation notes that indicate what was actually done on the ground, such as: maps, tallies, plot locations used, plot location details and any deviations from the cruise design.
 - 3. Cruise reports printed from cruise software, if applicable.
 - 4. Work sheets that document any adjustments made to the volume shown on the cruise reports.
 - 5. Traverse data and reports (GPS plot locations or azimuth-distance). Determine and record timber sale area volumes. At a minimum:
 - a. Develop a cruise summary that lists volumes by the various sale units/blocks or by individual stands.
 - b. Record total volume by product and species on DNR Form 2460-001.
- D. Utilization specifications for cruising will detail pulpwood volumes and sawlog volumes. Hardwood logs with a small-end diameter inside bark of at least 10.6" should be cruised and scaled as saw logs, and softwood logs with a small-end diameter inside bark of at least 7.6"should be cruised and scaled as saw logs. Sawlog volume estimates should be separated from cordwood volume estimates during cruising whenever there are at least 2 MBF of estimated sawlog volume on a sale.
- E. Units from cruise (MBF, cds, tons, other) must be detailed. Total sale volumes will be reported on DNR Form 2460-001 in units of cords and MBF. The Wisconsin DNR weight conversion factors will be used, TSH, chapter 12 to convert any weight scaled products.

- F. Comingling volume from cruise (e.g. 18 product code designation) can be done after all individual volumes are calculated. If products will be sold as a comingled product, the establishment notice (i.e. white portion of Form 2460-001) must report separate volumes by cords and MBF and the volume may be reported as comingled on the sold and final notice (i.e. the gray and blue portions of Form 2460-001).
- G. The Wisconsin DNR quality control and consistency measures are to conduct cruising evaluation for cruises conducted by consulting foresters. This will be done as a 5% check cruise by the Wisconsin DNR personnel.

V. Appraisals

UAS

- A. Use DNR TSH appraisal procedures outlined in chapter 32. Use TSH base rates for that County or adjacent DNR property on 2460-001 page 2. This appraisal process shall determine the *State appraised value* and *State minimum acceptable bid values*, and shall not be used to establish the *FS appraisal value (GNA Required Payment)* to be reported to USFS for the purpose of determining required payments to the USFS and Program Income (See Appendix D Timber valuation appraisal for more detail).
- B. Use Wisconsin DNR rounding guidelines for final value and volume numbers, TSH, chapter 43.
- C. *State minimum acceptable bid* values below *GNA required payment rates* will typically not be allowed.
- D. Reforestation and/or restoration work associated with a GNA timber sale will typically be completed by the State; however, such work will be assigned to either the State or USFS at the point of submission/approval of the silvicultural prescription. The FS minimum rates will include these costs, if not to be completed by the State.

VI. Map guidance

- A. Sale map to be developed detailing planned harvest areas and cruise/marking information. Sale maps will be created either by hand by using GIS software, see Wisconsin DNR TSH appendix A-9 for an example.
- B. The State may develop a GNA timber sale map template for map consistency.
- C. The State mapping elements and symbols will be used.
- D. Roads to be used, landings, when pre-identified, and other significant map features will be clearly defined on timber sale map.

VII. Prospectus Guidance

A. The State timber sale write up of prospectus will use elements in TSH chapter 60.

- B. The State will use the Timber Sale Notice and Report Form (Form 2460-001) to detail sale descriptions, species and product volumes, appraisal values and sale special conditions.
- C. All seasonal and operational restrictions will be clearly identified for each sale area or unit of the sale. These are typically stated in the NEPA document.
- D. No bid bond is required. Performance bond is required within 6 weeks of contract signing per TSH.
- E. Sale method, as described in TSH chapter 50, which includes lump sum (premeasured), mill-scaled or field-scaled sale systems, shall be stated on prospectus along with details of any special sale conditions to be met.
- F. Forest products sold from federal lands shall not be sold as certified wood under the State's forest certification certificates.
- G. Sale final write up will be signed by forester and the prospectus page and map will be reviewed and approved by the Wisconsin DNR sale coordinator or the Wisconsin DNR GNA Operations Leader.

VIII. Timber Sale Write up Completed

- A. GNA timber sale detailed elements shall be listed for all sales on DNR Form 2460-001 pages 1 and 2. Include Congressional District designation on Form 2460-001. Approval signature required by Wisconsin DNR Team Leader or the Wisconsin DNR GNA Operations Leader.
- B. Sale map shall be included and will reflect proposed harvest plan and stand marking information.
- C. Prospectus page developed for bidding package from cruise, marking, map and appraisal of total sale area.
- D. Review/approval of all sale write ups and prospectus will be done by Wisconsin DNR Team Leader or Wisconsin DNR GNA Operations Leader.
- E. U.S. Forest Service will approve each sale prior to advertising. Submit timber sale final write up to Chequamegon-Nicolet National Forest, Forest Supervisor or designated representative. When returned approved, sale advertising can commence.
- F. Record stand and management info for update of GNA records in WisFIRS data base as A-notice. WisFIRS will be modified to accept GNA sales.

IX. Advertising

- A. A sale prospectus package will be developed with bidding details and deadlines. This will include an informational cover letter, sale locator map, individual sale descriptions with estimated harvest volumes, minimum bid prices, and bid forms for perspective sale bidders.
- B. Prior to advertising, all sale materials for single or multiple sale areas will be reviewed by DNR Team Leader or DNR GNA Operations Leader for completeness.
- C. The Wisconsin DNR requires 2 newspaper ads in paper circulated in the County of sale, printed in consecutive weeks at least one week prior to bid opening.
- D. Mailing list from U.S. Forest Service will be shared to include their interested vendors in advanced mailing of sale notice.
- E. Web advertising will be developed to facilitate posting sale information on the Wisconsin DNR website. A post card can go out to mailing list for notice and location of bidding materials.

X. Bidding

- A. The State expects to typically hold spring and fall bid openings each year for GNA timber sales, most likely with an East and a West Chequamegon-Nicolet National Forest bidding location to be used to hold public bid openings. The specific location(s) will be included with mailings and website info.
- B. Wisconsin DNR TSH chapter 60 bidding process will be used.

XI. Contract Awarding to Acceptable Bidder

- A. Timber sale contract award is subject to the Wisconsin DNR requirements. Contracts are written up and proofed within 3 weeks from bidding day.
- B. Record keeping file to be set up and list the elements required on schedule 2400-005A-D.
- C. Performance bonds and workers compensation insurance certificates are due within six weeks of bid opening date and prior to work commencing.
- D. Timber sale contracts to be signed by the Wisconsin DNR Team Leader or Wisconsin DNR GNA Operations Leader prior to sending them to contractor for signature.
- E. Send Chequamegon-Nicolet National Forest Timber Program Manager, the Wisconsin DNR County and Public Forest Specialist, and other interested parties bid results summary.

XII. Financial and Documentation aspects of Timber Sale Contracts

- A. All timber sale financial record keeping will be completed by the State, and/or a county sub-awardee or contractor.
- B. Fill in and enter into WisFIRS the sold sale information as the B-Notice for 2460-001 data.
- C. Establish ledger and journal (either hardcopy or data base) for recording all sale contract transactions.
- D. Establish an active sale file to house all sale documents and financial transaction documentation.
- E. Entry of sold and completed timber sale notices in WisFIRS should occur within 30 days of sale award and close-out. Closed sales will be reported on a quarterly basis to the U.S. Forest Service Program Manager.
- F. All costs and expenses for GNA project work will be coded using a GNA activity code and recorded in the GNA Financial Plan spreadsheets, or associated tracking spreadsheet.

XIII. Sale administration

- A. Each GNA timber sale will have a sale administrator assigned to it.
- B. The Wisconsin DNR TSH forms to document sale activities include pre-sale meeting form 2460-009, sale harvest inspection record 2460-002 and sale closeout checklist 2460-013.
- C. Sale administrator is responsible for all file element retention as detailed in Wisconsin DNR TSH Chapter 70.
- D. Sale administrator will notify U.S. Forest Service Project Contact (District Ranger) through direct communication, phone call or email of pre-sale meeting with contractor.
- E. Conduct a pre-sale meeting with the contractor. This may include a Law Enforcement Officer from the Wisconsin DNR and U.S. Forest Service.
- F. Perform standard timber sale administration. Maintain written records of each project administration check, phone calls and any notes as part of the project record. Retain all written correspondence.

- G. Utilize designated GNA budget fund number for all transactions. All timber sale monies collected go to the State, and should be remitted using DNR form 2460-003 or equivalent.
- H. Upon inspection and completion of all contract elements each timber sale project, complete final inspection report and begin close out of the sale.
- I. Return any unused portion of performance bonds to purchaser through sale transaction form 2460-003.
- J. Complete all closeout procedures of final sale close out as part of the project file.
- K. Closeout form 2460-013 will be completed and filed with sale documents, and will include a closeout summary with items outline in section XIV.B. below.
- L. Sale administrator turns in all file items to DNR GNA Operations Leader.

XIV. Reporting

- A. The State sale summary reports will be submitted on a quarterly basis for established, sold and closed-out sales to the Chequamegon-Nicolet National Forest Timber Program Manager. The report of closed sales shall be utilized to generate an invoice to the State for GNA Required Payments.
- B. Timber sale closeout summary worksheet will be included with closed sale files. The closed sales files will include at a minimum a sale synopsis with the following information:

Final volume removed Final inspection report List of substantial events or changes during sale administration such as unit boundary changes, changes to planned transportation access, contract breaches, disputes or claims Prescribed reforestation activities completed through timber sale operations (e.g. aspen site prep or canopy gap cleaning).

If a portion of the performance bond was retained to accomplish on the ground work after contract closure, such as road maintenance or erosion control, a follow up final inspection or other record of completion of these activities must also be provided.

C. Files for closed sales shall be transmitted to the U.S. Forest Service quarterly by either the administering forester or the Wisconsin DNR GNA Operations Leader, with at least one copy going to the Chequamegon-Nicolet National Forest GNA Program Manager. The time and effort for preparing all reports shall be tracked and included as a project expense for reimbursement as part of the project.

D. For all policies and procedures not specifically described in the GNA Supplemental Project Agreement, the standard shall be to apply the DNR guidance utilized on department lands, when applicable, as described in the Timber Sale Handbook, Public Lands Handbook, or similar department guidance document. This includes State guidance and provisions for the salvage of timber associated with insect disease or other disturbance events

XV. Wisconsin DNR Good Neighbor Timber Sale Project Quality Control Procedures

- A. Wisconsin DNR Quality Control for GNA Timber Sale Projects
 - 1. At completion of marking each stand, report stand number, paint colors used and acres to GNA Operations Leader.
 - 2. Quality control and consistency measures: Evaluation will be done for marking completed by consulting foresters, check cruise by Wisconsin DNR personnel, as detailed in the Consulting Contractor Contract. Notify Chequamegon-Nicolet National Forest District POC when marking/cruising is completed by timber sale prior to timber sale contract preparation.
 - 3. Timber sale write up (including Form 2460), map and supporting materials for each management area will be reviewed and approved by DNR Team Leader or DNR GNA Operations Leader. This review will be to examine the sale details to evaluate cruise accuracy, proper sale documentation, and completeness.
 - 4. Timber sale contract approval and administration subject to Wisconsin DNR GNA timber sale contract requirements. Required elements include FISTA training, worker's compensation insurance confirmation, performance bond receipt and other timber sale contract specifications.
 - 5. Perform standard timber sale administration consistent with guidance in Timber Sale Handbook. Maintain written records of each project administration inspection, all correspondence, and any notes as part of the project record. Conduct a pre-sale meeting with the contractor, to be documented on DNR Form 2460-009. Document regular sale inspections on DNR Form 2460-002. Timber sale closeout (including DNR Form 2460-013) reviewed and approved by DNR Team Leader or DNR GNA Operations Leader.

- B. U.S. Forest Service Quality Control for GNA Timber Sale Projects
 - 1. U.S. Forest Service will develop and conduct training for State personnel for silvicultural plan writing.
 - 2. Chequamegon-Nicolet National Forest District Silviculturists will review completed silvicultural plan and marking guidelines and communicate approval or request modifications within 15 business days of submission or provide written notification with justification and alternative completion timeframe.
 - 3. Wisconsin DNR shall submit timber sale final write up to the Chequamegon-Nicolet National Forest' Forest Supervisor or designated representative. Chequamegon-Nicolet National Forest Timber Program Manager or alternative designee of the Forest Supervisor will review and approve each draft timber sale contract prior to advertising and will communicate approval or request modifications within 15 business days of submission or provide written notification with justification and alternative completion timeframe.
 - 4. U.S. Forest Service designated personnel will "walk-through" approximately 5% of marked stands prior to approval of timber sale contract to review adherence to silvicultural prescriptions. Results of "walk-throughs" will be critiques and suggestions for future work and provided to the DNR POC in writing. "Walk-through" will not necessitate re-marking if the spirit of the prescription and primary objectives is adhered to.
- C. U.S. Forest Service/State Joint Quality Control for GNA Timber Sale Projects
 - U.S. Forest Service and the State will perform a joint inter-disciplinary review of 1 closed timber sale per year. This review will be led by the U.S. Forest Service and focus on the achievement of project objectives/outcomes and provide positive feedback for future project work. The main objectives of the review are to:
 - a. Assess the attainment of management objectives and compliance with resource mitigation measures as set forth in the project-specific environmental documentation (NEPA) and the Forest Plan.
 - b. Measure and evaluate compliance with applicable laws and regulations.
 - c. Identify and prevent (or resolve) controversial issues.
 - d. Identify timber sale situations that may lead to negative environmental impacts and recommend modifications.
 - e. Provide feedback to U.S. Forest Service, State staffs and sub-awardees involved with GNA projects.
 - f. Evaluate post-sale monitoring of NEPA identified mitigation measures.
