Cooperating consultant foresters,

Sealed bids will be received by at the Florence Natural Resource Center, Florence, Wisconsin, up to 3:30 p.m. on Tuesday, February 13, 2018 for establishment of harvest boundaries on future timber sales.

Contract ending date for the harvest boundary establishment: **June 15, 2018.**

Task 1: Establish property boundary using a Wisconsin licensed land surveyor to create a legal survey for the property. Lines and corners to be established are identified on the attached maps.

Task 2: Corners need to be established with using a ¾” by 30” minimum length metal rod.

Task 3: Lines need to be marked every 25 feet more or less or closer so that each marked tree is visible from the adjacent marks using blue boundary paint. A steel fence post needs to be placed every 330 feet along the indicated lines.

Task 4: Provide a hard copy plat of survey to the county surveyor and DNR property manager along with a GIS ArcMap shape file or digital CAD drawing that can be opened in ArcMap including information on which projection was used to create the shape file.

The cooperating consultant forester is responsible for coordinating with and paying the licensed surveyor.

When all tasks are complete the cooperating consultant forester will invoice the State of Wisconsin DNR – Florence Natural Resource Center for the bid amount on the contract.

The winning bidder will receive a contract to review and sign by March 15, 2018.






