MEADOW VALLEY WORK UNIT AND OTHER STATE PROPERTIES**

Spring 2020

The property Superintendent or his agent will receive sealed bids at the Necedah Ranger Station, PO Box 247, 400 Birch St, Necedah Wisconsin 54646 for 24 tracts of timber located on the Meadow Valley Wildlife Area, Buckhorn State Park, Monroe County Other State Lands, Sandhill Wildlife Area and Wood County Wildlife Area. Bids will be accepted until **10:00 AM on Thursday May 21st, 2020** and will be opened immediately thereafter.

Due to Covid-19 and the associated guidance. This bid opening will be CLOSED to the public. Bids must be received via the mail or hand delivered before 10:00 AM on Thursday May 21st, 2020. If you would like to call in to hear/participate in the bid opening please contact the Necedah Ranger Station (608) 565-2519 prior to the bid opening for further details.

The tracts are located in the Towns of Kingston, Cutler, Necedah and Germantown in Juneau County. The Town of Scott in Monroe County. The Towns of Remington and Dexter in Wood County.

Bidding Requirements

All bids must be submitted on a Department Timber Sale Bid Form and shall include the following:

1. Tract number (including the property – MVWA, SHWA, WCWA, MCSL, BHSP)
2. List of all species to be cut and estimated volumes as listed on the timber sale prospectus.
3. Bid price per unit for each species listed.

4. **No bid bond is required.** Winning bidders will have 6 weeks from the date of the bid opening to submit acceptable performance bond to the department. If the winning bidder fails to execute the contract and submit an acceptable performance bond, the bidder will be required to forfeit to the department an amount equal to 10% of the total bid amount. Failure to forfeit the 10% penalty will result in the bidder being considered ineligible to bid on any state timber sales for a two-year period.
5. Indicate the type of performance bond to be used by checking the appropriate box on the bid form.
6. Signature and address of the bidder.
7. Total bids must meet or exceed the advertised value / minimum acceptable bid listed for the entire sale to be valid.

Additional Requirements

At any time prior to the reading aloud of any bids for a particular sale, bidders may withdraw their bid from consideration. This can be done in person or by written instruction to the DNR Forester conducting the bid opening.

Winning bidders will have **6 weeks** from the date of the bid opening to submit an acceptable **performance bond** to the department. The performance bond must be equal to 15% of the total bid value or \$1,000.00, whichever is greater. An Irrevocable Letter of Credit issued as a performance bond will be required to be 4 1/2 years in length. Letter of Credits for sales awarded this bid opening should be written to expire **December 31st, 2024**. **The performance bond needs to be mailed or hand delivered to the Necedah Ranger Station, PO Box 247, Necedah WI 54646.**

Worker's compensation Law: The contractor (purchaser) shall provide the Department with an original Certificate of Insurance indicating that Worker's Compensation Insurance coverage is provided for all of the contractor's employees working under the contract during its duration. This shall be in the Department's file prior to any performance under this contract.

Payments: Timber will not be removed from any sale area until paid for or a satisfactory guarantee for payment is made. However, qualifying contractors have the option to sign a contract under the deferred payment program. Under this program, payment shall be received by the DNR Forester within 30 days of the date of billing. Failure to pay within the 30 day period shall result in the contractor being required to prepay stumpage on the remainder of the sale and a 1.5 % every 30 days late interest penalty being assessed on stumpage due.

Training Requirement: The purchaser is responsible for ensuring that the actual logging contractor complies with the Wisconsin SFI training standard as adopted by the SFI Implementation Committee (SIC). Criteria for the standards can be found at the website www.fistausa.org/sfi_standards.html, or by contacting the Forest Industry Safety and Training Alliance (FISTA). Purchaser must provide documentation to the Seller indicating that training has been completed.

Sales and Use Tax Exemption Certificate: The contractor (purchaser) shall provide the Department with a copy of their Department of Revenue Sales and Use Tax Exemption Certificate. This shall be in the Department's file prior to any performance under this contract.

The Department of Natural Resources reserves the right to reject any or all bids.

ADVERTISED VALUE / MINIMUM ACCEPTABLE BID: \$31,427.50

SALE OBJECTIVES: The primary objective of the timber sale is to regenerate the species in place for the benefit of both wildlife species and recreators utilizing Buckhorn State Park. This objective will be accomplished by harvesting all trees with retention of large healthy trees, primarily oak to encourage regeneration by seed and coppice sprouting. Reserved trees will provide many benefits to wildlife and will increase aesthetics.

CUTTING AREA DESCRIPTION: This sale is on relatively flat ground with no significant slopes. The soil is sandy and drains readily. The timber sale cutting units are bound by red lines surrounding the sale. Cutting shall take place within the red lines in all stands and shall not extend past marked trees on any portion of the stands. The East line of the Northern most unit is bounded by private land and has blue marks on trees, cutting shall not take place past the blue marked trees.


CUTTING REQUIREMENTS/SPECIFICATIONS:

- Cut all merchantable trees except for those marked with green paint. Do **NOT** cut trees with green, red or blue paint marks.
- Utilize all trees to a 4 inch top diameter.
- Cut all trees greater than two inches in diameter.
- No rutting will be allowed. Rut damage provisions are included in the timber sale contract.
- **Unit 1 – NO harvesting from April 1st to September 30th due to oak wilt and recreation restrictions.**
- **Unit 2 – NO harvesting from April 1st to July 15th due to oak wilt restrictions.**

ACCESS/SEASONAL RESTRICTIONS: This sale has multiple roads for access including 29th Street, 31st Street, 33rd Street, 20th Ave. and 22nd Ave. Contractor will be responsible for road construction and maintenance and/or upgrades for truck traffic into the sale area. All roads must be returned to as-is or better condition at the end of the contract period. This sale is to be cut only during dry/frozen ground conditions. Purpose of Sale:

The sale area contains jack pine dying of old age and oak death from oak wilt disease. The purpose of this sale is regeneration through a shelterwood and seed tree method leaving scattered black and white oaks, as well as leaving large red and white pine as legacy trees.

Cutting Specifications:

Unit A - Cut all trees >2" DBH except those marked in green paint. 45 acres.

Unit B - Cut all hardwoods and jack pine >2" DBH except those marked in green paint. Only cut red and white pine marked with orange paint. 13 acres.

Special Operating Requirements and Slash Disposal:

1. This sale is located mainly on dry ground. Stands shall only be harvested between October 1st and April 1st. No harvesting during 9-day gun deer season. Care should be taken to avoid rutting and soil compaction. The far southeast portion of Unit A must only be harvested during solid ground conditions.
2. The sale harvest boundaries are marked in red paint. Do not cut red-painted trees. **Equipment must not operate outside of red painted boundary because of sensitive cultural resources near bluff and rock area.**
3. No biomass harvesting is allowed on this sale due to nutrient-poor soil types.
4. All pine products cut between March 1st and August 30 must be removed from the sale area within three weeks from time of cutting to control bark beetle populations. Pine products cut during the remainder of the year must be removed before March 15th.
5. Do not cross state park trails except in flagged locations designated by DNR Forester. Skid roads, log landings, and interior of harvest stands will be free of forest products and ruts and slash and will meet the aesthetic standards in the Silvicultural Handbook (2431.5) and Chapter 13 in WFMG at the end of the timber sale. In other words, recreational trails, new roads, and log landings will be restored to pre-harvest conditions and slash reduced for aesthetics.
6. Slash must be evenly lopped/scattered within the sale boundary and shall be deposited a minimum of **50** feet from the mowed right-of-way of any highway, town road, or recreational trail. Unmanaged slash can be aesthetically unappealing. It can also significantly increase the cost of future trail construction. All slash should be removed entirely or hauled a minimum of 50 feet from trail/road edges and flattened so that it is no taller than 24 inches above the ground. Do not bury seedlings or saplings with slash.

General Requirements:

1. All landings and new roads must be approved by a DNR forester before operations begin.
2. All designated tree species must be cut and forwarded concurrently with the sale.
3. All stumps shall be no higher than the stump diameter, or 10 inches, whichever is less.
4. Cut or knock down all dead trees within 50' of recreational trails, but leave all others standing. These are important wildlife habitat. Dead trees that are cut and left shall be left in big pieces on the forest floor.
5. Utilization: cut and use all designated trees with one or more 100" sticks to a 4" top diameter.
6. Notify the DNR forester before you start the job, and each time you pull out or return to the job.
7. Any berms removed during harvesting operations must be put back to the satisfaction of the DNR Forester.
8. Any trees cut or pushed over for new roads or landings must be utilized or cleaned up to the DNR Forester's satisfaction.
9. **Wisconsin's Best Management Practices for Invasive Species applies – contractor must clean equipment before entering and leaving the sale area! This involves brushing away all dirt and cleaning air intakes of debris.**




Bluffside Black Oak Sale

Purpose of Sale:

The sale area is a mixture of thinning and regeneration harvests. Stands are currently fairly mixed due to a major wind event in the late 90's. This sale is meant to manage these stands to gain more uniformity and overall stand health.

Cutting Specifications:

Blue paint is boundary to private land. Red paint denotes stand boundary. Do not cut blue or red-painted trees.

Unit A – First thinning. Cut every third row of the pine plantation. There are no paint marks in this stand. 13 acres.

Unit B – Thinning. Cut all trees marked with orange paint. 12 acres.

Unit C – Overstory removal. Cut all trees >2" in diameter except those marked with green paint. 16 acres.

Special Operating Requirements and Slash Disposal:

1. This sale is located mainly on dry ground. Do not operate equipment within 50 feet of the Big Creek's ordinary high-water mark. Harvest during dry or frozen ground only.
2. The harvest area is marked in red for stand lines and blue paint for boundaries to private land. Do not cut red or blue-painted trees.
3. No biomass harvesting is allowed on this sale due to nutrient-poor soil types.
4. All pine products cut between March 1st and August 30 must be removed from the sale area within three weeks from time of cutting to control bark beetle populations. Pine products cut during the remainder of the year must be removed before March 15th.
5. All roads and trails used by logging equipment should be left in condition satisfactory to property manager.
6. Slash must be evenly lopped/scattered within the sale boundary and shall be deposited a minimum of 10 feet from the mowed right-of-way of any highway, town road, or recreational trail. Slash within 50 feet of all town roads and recreational trails must lie within 2 feet of the ground. Do not bury seedlings or saplings with slash.
7. **The pine stands are located within the 25-mile Heterobasidial Root Disease (Annosum) area, and require stump treatment unless harvested between December 1 and March 31. Treatment must be performed by a Certified Pesticide Applicator. Treatment involves chemically treating all fresh-cut stumps of pines of merchantable size by applying either CELLU-TREAT (disodium octaborate tetrahydrate) or Rotstop C (biological fungicide). Treatment shall be made as soon as possible and no later than one day after harvest and a dye product shall be added to liquid solutions for inspection purposes. The cost of this application can vary based on application method and harvest conditions, but should be considered when submitting bids on these timber sales. All pine stumps must be treated for HRD.**

General Requirements:

1. All landings must be approved by a DNR forester before operations begin.
2. All designated tree species must be cut and forwarded concurrently with the sale.
3. All stumps shall be no higher than the stump diameter, or 10 inches, whichever is less.
4. Leave 1-3 large, dead trees per acre for wildlife if present. Dead trees that are cut shall be left in big pieces on the forest floor.





Barrell Brook Sale





- Within the harvest area, cut all trees greater than 1’’ in diameter **except trees Marked in Green Paint, Tamarack, and Red Pine. Furthermore, do not cut any Jack Pine containing less than 1-100 inch pulpwood sticks.**




Sandhill Wildlife Area Timber Sale Map




Wood County Wildlife Area Timber Sale Map


