## **BIDDING REQUIREMENTS**

- 1. Bidding Procedure for Timber Sales
  - a. Bids will be made by <u>species</u> for each tract.

b. Estimated volumes and utilization specifications are listed on individual sale prospectus maps. Bid according to volumes listed on individual sale prospectus and/or maps.

c. The <u>high bidder</u> will be determined by the <u>greatest total bid</u> for each tract.

d. Bids will be opened in random order.

e. **Bidders in attendance (virtual)** can remove their bid from consideration before each individual tract is opened. Bidders must identify themselves by clearly stating their name, address, and telephone number PRIOR to a bid being opened to withdraw their bid from consideration.

- 2. Bids may be made on one or more tracts.
- 3. <u>Submit each bid in an **individual sealed envelope** marked "Bid for Timber Stumpage" with the timber sale name, and tract number on the outside. Wisconsin DNR Timber Sale Bid Forms must be used to make bids on DNR timber sales and is included with the individual sale prospectus.</u>
- 4. A per unit bid must be made on every required item on a tract. No "zero- \$0.00" bids for any species or products will be accepted and bid will be rejected.
- 5. Winning bidders will be notified within 24 hours of bid opening and must sign the timber sale contract and submit an acceptable performance bond within 6 weeks of the bid opening. If the winning bidder fails to execute the contract and submit an acceptable performance bond, the bidder shall be required to forfeit to the Department an amount equal to 10% of the total bid amount. Failure to forfeit the 10% penalty will result in the bidder being considered ineligible to bid on any state or GNA timber sales for a two-year period.



- 6. A <u>Performance Bond or Letter of Credit</u> is required before awarding of contract. The bond shall be fifteen percent (15%) of the total bid value or a minimum of \$1,000.00, whichever is greater. The bond will be held intact by the Department of Natural Resources until the satisfactory completion of the timber sale contract. Performance bonds in a form of other than cash for these sales must expire no earlier than 1-year past contract expiration date.
- 7. For sales requiring pesticide applications (e.g. HRD treatment), the Purchaser shall ensure and provide documentation that any person(s) who applies or handles any pesticide on Department lands is covered by a valid Pesticide Business License, Individual Commercial Applicators License, and Forestry 2.0 Certification issued by the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) prior to pesticide application. The cost of this application can vary based on application method and harvest conditions, but should be considered when submitting bids on these timber sales.
- 8. The Department of Natural Resources reserves the right to reject any and all bids.

## **SALES TAX CERTIFICATION**

1. A <u>Sales and Use Tax Exemption Certificate</u> must be provided at the signing of the contract. This certificate is required to cover a contractor or individual reselling stumpage harvested for firewood/fuelwood and mills and manufacturing facilities. ## **UTILIZATION**

- 1. All trees designated for cutting will be utilized to a 4" small end diameter for pulp, 10" small end diameter, (grade 3 or better) for sawlog and 8" small end diameter for bolts, unless stated otherwise in the prospectus.
- 2. When designated for cutting, all trees containing one (1) or more one hundred inch (100") long stick to a four inch (4") minimum top diameter will be considered merchantable.

## SCALING AND PAYMENT

- 1. If eligible for deferred payment option, payment for timber removed from site must be made within 30 days after invoice.
- 2. If not eligible for deferred payment option, no wood will be hauled from the sale area until advanced payment is made.
- 3. If sold as a lump sum sale, payment in full must be made on entire sale, or by the cutting block, or by some other means as mutually agreed upon by Department of Natural Resources and contractor.
- 4. The mill scale ticket system will be used as the preferred method of sale administration. Other scaling systems may be used at the discretion of the Department of Natural Resources.
- 5. If a woods scale system is used, all cordwood or logs will be piled for scaling. Piles will be level and square with at least 5 cords per pile or 8 MBF. At least 5 cords or 8 MBF will be piled before a scale is requested. Scaling requests must be made at least one day in advance.
- 6. No refunds of stumpage payments will be made for un-removed wood, and wood left on the sale area at contract expiration shall revert to the seller.
- 7. Scribner Decimal C Log Rule shall be used for scaling logs. Conversion from MBF to cords or cords to MBF shall be 2.44 cords per MBF for softwoods and 2.2 cords per MBF for hardwoods.
- 8. Weight scale conversions will be at rates as specified in the Department of Natural Resources timber sale handbook listed below, unless the individual timber sale has specific mixed species pro-rates/conversions.

#### **CONTRACT PERIOD**

1. All contracts offered during this bid opening will expire **June 30<sup>th</sup>**, **2029** unless noted on individual timber sale map.

#### **CONTRACT EXTENSIONS**

Contract extensions will not be granted without justifiable reason. Justification will be determined by the Department of Natural Resources. Contract expiration dates are given on the individual timber sale. Contract extensions are not guaranteed. All extensions, if granted, will be for 1 year. Extension requests will be considered with the following conditions:

#### One and Two-year contracts

- 1st extension 5% increase in stumpage rate
- 2<sup>nd</sup> extension an additional 10% increase in stumpage rate

#### **Three and Four-year Contracts**

• 1st extension – 15% increase in stumpage rate (only 1 extension granted)

#### **OTHER CONDITIONS**

The Purchaser shall purchase and apply an approved fungicide (Rotstop C or Cellu-Treat) to all cut pine stumps and horizontal wound surfaces as follows:

- a) Pesticide applicators must be certified/licensed by DATCP for this treatment.
- b) All stumps shall be treated by the end of each day of cutting from April 1 -November 30. Treatment may be required from December 1-March 31 if abnormally warm for an extended period. To be determined by DNR forester.
- c) All stumps shall be left clear of logging slash to allow for the application and inspection of the approved fungicide.
- d) A marker dye shall be added to the solution to monitor application coverage.
- e) Extra care must be done to minimize damage to residual trees.
- f) If HRD is discovered prior to the completion of this harvest, a harvest protocol of infected area(s) shall be established, and all harvesting equipment must be cleaned of soil prior to leaving this harvest.
- 3. Because of threats from invasive plant species, logging equipment coming onto each individual timber sale on state lands must be washed free of debris to prevent transfer of seeds. Any simple washing is acceptable. Inspection of equipment will be done when logging equipment arrives on-site before logging operations begin. Timber mats must also be free of debris when arriving on-site.

# **Insurance**

The "Contractor" (purchaser) shall provide the Department of Natural Resources with a Certificate of Insurance counter-signed by a Wisconsin Resident Agent, indicating that Worker's Compensation Insurance coverage is provided for the duration of the contract prior to any performance under it. Contractor claiming exemption, independent status, the contractor/purchaser will be required to submit a signed, notarized affidavit that affirms their exempt status pursuant to the criteria listed in section 102.07(7)(b), of the Wisconsin Statutes.

Contract may contain other provisions. Contracts may not be assigned. A sample copy of the contract is available upon request.

# TRACT #5950-2-24 IS AN OPTIONAL PULPWOOD VOLUME SALE

The Division of Forestry is offering a new method for advertising timber for sale. In this timber sale, there is both required and optional volume to be utilized, indicated by minimum diameter.

This sale contains Ash, Aspen, Mixed Hardwoods, and Oak pulpwood volume (4-8" diameter) that is **optional to bid on**. Contractors may bid on all, none, or a portion of the **optional** pulpwood volume listed on sale prospectus and bid form. Contractors choose the volume available to bid on to meet their ability to move the pulpwood.

This sale will be awarded to the highest bidder (value) for the sale regardless of the total volume bid on. The State reserves the right to reject any and all bids.

- 1) Contractor MUST bid on all <u>required</u> volume, and must cut and remove that specified size (e.g. 8" and larger) required volume.
- 2) Contractor has the **<u>option</u>** to bid on 0-100% of the **<u>optional</u>** 4" and larger volume. You will be required to fill in the volume and value in the bid form provided.
- 3) If the winning bidder bids on a portion or all of the **<u>optional</u>** volume, upon harvesting the sale:
  - a. Will be required to utilize the **<u>optional</u>** bid volume. In the event the contractor is unable to market that volume, the contractor will be invoiced for the **<u>optional</u>** volume bid on and required to pay. Contractor would then be allowed to leave the unused volume in the sale per slash requirements.
  - b. Chooses to utilize additional <u>optional</u> volume above the bid volume amount, will be billed at the bid price for <u>optional</u> volume.
- 4) If the winning bidder, <u>doesn't bid</u> on the optional volume, **and** upon harvesting the sale:
  - a. Wants to utilize any of the optional volume, a contract rate and volume will be agreed upon between the buyer and seller and included in a contract amendment.
- 5) When required and optional volume are hauled together (mixed product loads), the volume will be invoiced at the prorated purchased value and volume for both (see example below). If the purchaser sorts the required and optional volume by size, the loads will be invoiced based on the bid prices for each. Example: 400 tons of required aspen purchased at \$20.00/ton AND 200 tons of optional aspen purchased at \$10.00/ton. Mixed loads will be invoiced at \$16.67/ton.



- 3) Emerald Ash Borer (EAB) is infesting this sale, the majority of the ash is in a dead and dying state at the time of establishment of this sale
- 4) See contract for additional considerations

## \*Optional Pulpwood Specifications (Oak, Mixed Hardwood, Aspen and Ash Pulpwood volume is optional to bid on):

- If contactor bids on pulp volume, contractor is required to utilize (i.e., harvest, remove from the site, and pay for) the volume and value bid on.
- If contactor who bid on a portion of the pulpwood chooses to utilize additional volume over the volume bid on, the additional volume will be charged at contract rates.
- If a contractor who did not bid on the pulpwood is awarded the sale and the contractor later wants to utilize the pulp, a contract amendment with volumes/values will be made.
- Pulpwood that is not bid on remains the property of the DNR and may not be utilized except as provided in a contract amendment, if any.
