Special Sale Conditions:

Equipment use will be restricted to very dry or frozen ground conditions. Portions of this sale are in the Flambeau River Scenic Management Area. Operations within this portion of the sale shall be conducted during leaf off conditions (approximately October 15th-March 31st.)

No harvest in selection cut area may occur from April 1- June 30 due to bark on residual trees being easily damaged during this time period.

Decking will be done along woods trails within the sale area. Decking off River Road requires approval of Cedar Rapids township by contractor. If decking is allowed along River Road, all slash and ends will be removed from the roads and ditches concurrently with each load. No decking will be allowed on access road to Hervas Landing.

Cutting will not be allowed in shelterwood area until scarification is completed by the State. Harvest shall be within one year of scarification.

To make areas of sale operable during dry conditions, existing trails and new stub roads will most likely need pit run material. The state will provide the pit run material, but it will be the responsibility of the contractor for loading/hauling/leveling any pit run needed for decking on these existing roads and new stubs.

Slash that is within 100 feet of River Road will be lopped and scattered to within 2 feet of the ground by the contractor.

No slash will be left in the ditch line of River Road. Any damage done to River Road or the ditch lines is the responsibility of the contractor.

Any new access points will need to be bermed with logging debris. Upon completion, all woods roads and access points shall be leveled, reditched if necessary and returned to the condition prior to the sale.

Avoid government survey monuments illustrated on prospectus map.
