Utilization specifications for cordwood will be 1 stick (100 inches) to a 6-inch top diameter.

¹Mixed Pulp includes 62% hard maple, 16% red maple, 15% ash, 4% yellow birch, 2% cherry, and 1% white birch, basswood, and ironwood combined.

²Mixed Conifer includes 58% balsam fir, 22% tamarack, 16% white spruce, and 4% white pine.

³Red Pine includes 9 MBF.

⁴Mixed Saw includes 8 MBF yellow birch, 1 MBF cherry, and 1 MBF basswood and white birch combined.

Other species not mentioned will be charged at the mixed pulp, mixed conifer, or mixed saw price.

The performance bond will be 15% of the total sale value. The contract end date is **June 30, 2028**

SPECIAL SALE CONDITIONS:

Yurt Management Area:

The area as indicated on the map, including the parking area at the end of Feleen Road and the trail leading to the yurt, may only be used *after* the close of the 9-day gun deer season, and activities must be completed *before* April 1st. The parking area and trail must be clear of decked wood, equipment, and any slash, tops, ends or debris after this date. The open area around the yurt will remain clean and not be used for decking, piling, or forwarding.

The yurt access trail may be used when it is frozen. Damage to the trail or gate will be promptly repaired to maintain accessibility.

Roads and Access:

The ATV/snowmobile trail, Oxbo Drive, Feleen Road, the parking area at the end of Feleen Road, and the yurt access trail will remain open for use. Three inches of snow will remain on the snowmobile trail, weather permitting.

Permission must be obtained from Town of Draper before decking on Oxbo or Feleen roads. Decking may be difficult along parts of Feleen Road due to slopes and wetlands.

All slash, ends, and logging debris will be removed from the roads and ditches of town roads and the ATV/snowmobile trail with each truckload. All slash within 100' of town roads and the ATV/snowmobile trail, the Flambeau River, and within the yurt management area must be lopped and scattered to within 2' of the ground.

The stream and drainage will be crossed on the existing trails, where there are existing culverts.

Exercise caution around powerlines along Oxbo Drive. Do not deck or load underneath them.

Operations:

Harvesting is permitted during very dry or frozen ground conditions.

Portions of this sale are within the Flambeau River Scenic Management Area. Operations within this area shall be conducted during leaf off (October 15th – March 31st). Harvesting in the remaining red pine plantation area is permitted except during April, May, and June due to easily damaged bark at this time.

Areas of sale have steep slopes. Care should be taken to avoid erosion or rutting leading to channelized flow.

To preserve as much existing regeneration as possible, the forwarder should follow in the tracks made by the processor. The processor should fell trees onto trails or tracks to minimize excess damage. Only short wood forwarding is allowed.

All pine cut or piled between May 1st and August 1st shall be removed within 21 days, and all wood decked within 400 feet of the river must be removed prior to April 1st of each year.

All additional restrictions listed in prospectus and standard contract apply unless specified.
