## Utilization specifications for cordwood will be 1 stick (100 inches) to a 6-inch top diameter.

Other species not mentioned will be charged at the mixed pulp/saw price.

## **SPECIAL SALE CONDITIONS:**

Equipment use will only be allowed during very dry or frozen ground conditions due to wet soil conditions. Access may be restricted to frozen conditions due to soil conditions of trail.

To make access operable during very dry conditions, existing trail will most likely need pit run material. The state will provide the pit run material, but it will be the responsibility of the contractor for loading/hauling/leveling any pit run.

Harvesting in selection area allowed outside of April, May, and June.

Use of a continuous rotating saw head will not be allowed in the selection area or the canopy openings.

If decking on Tower Hill Road, all slash, ends, and logging debris including bark will be removed from the roads and ditches concurrently with each truckload.

Tower Hill Road is also a snowmobile/ATV trail. 3" of packed snow will be maintained on Tower Hill Road, weather permitting.

Proposed roads/skid trails are indicated on map and may be used to access the harvest areas. Modifications may be made with approval of forester. Other new construction must be approved by forester.

Culvert placement is needed at drainage. DNR staff will complete the placement of the culvert. This will need to occur prior to harvesting.

Contractor is required to close road at designated map location by placing a debris berm.

No slash to be left beyond the red paint line into the State Natural Area. No slash to be left beyond the red line along Lake of Pines. All slash within 200' of Lake of the Pines will be lopped and scattered to within 2' of the ground.

All additional restrictions listed in prospectus and standard contract apply unless specified.
