Landings are required at approximate locations designated on map.

Parking equipment or decking wood is not permitted in the powerline right-of-way. The right-of-way is tree line to tree line.

The snowmobile trail is used for multiple sales. It is the responsibility of the contractors to determine logistics for hauling and road repair.

Three inches of snow will remain on the snowmobile trail, weather permitting.

Decking on snowmobile trail should be kept to a minimum. If decking on the trail, all slash and ends will be removed from the trail concurrently with each truckload.

Skid trail entrances on the snowmobile trail will be minimized.

All slash within 100 feet of the Flambeau River and the snowmobile trail shall be lopped and scattered to within 2 feet of the ground.
