The cutting area is approximately 29 acres.

The contract period is 1 years.

All trees that will yield one or more 100-inch sticks to the minimum top diameter chosen by the bidder will be cut and utilized.

2/Contains approximately 235 tons and 2.1 MBF white birch, 7 tons and 0.4 MBF red oak and 50 tons red maple.

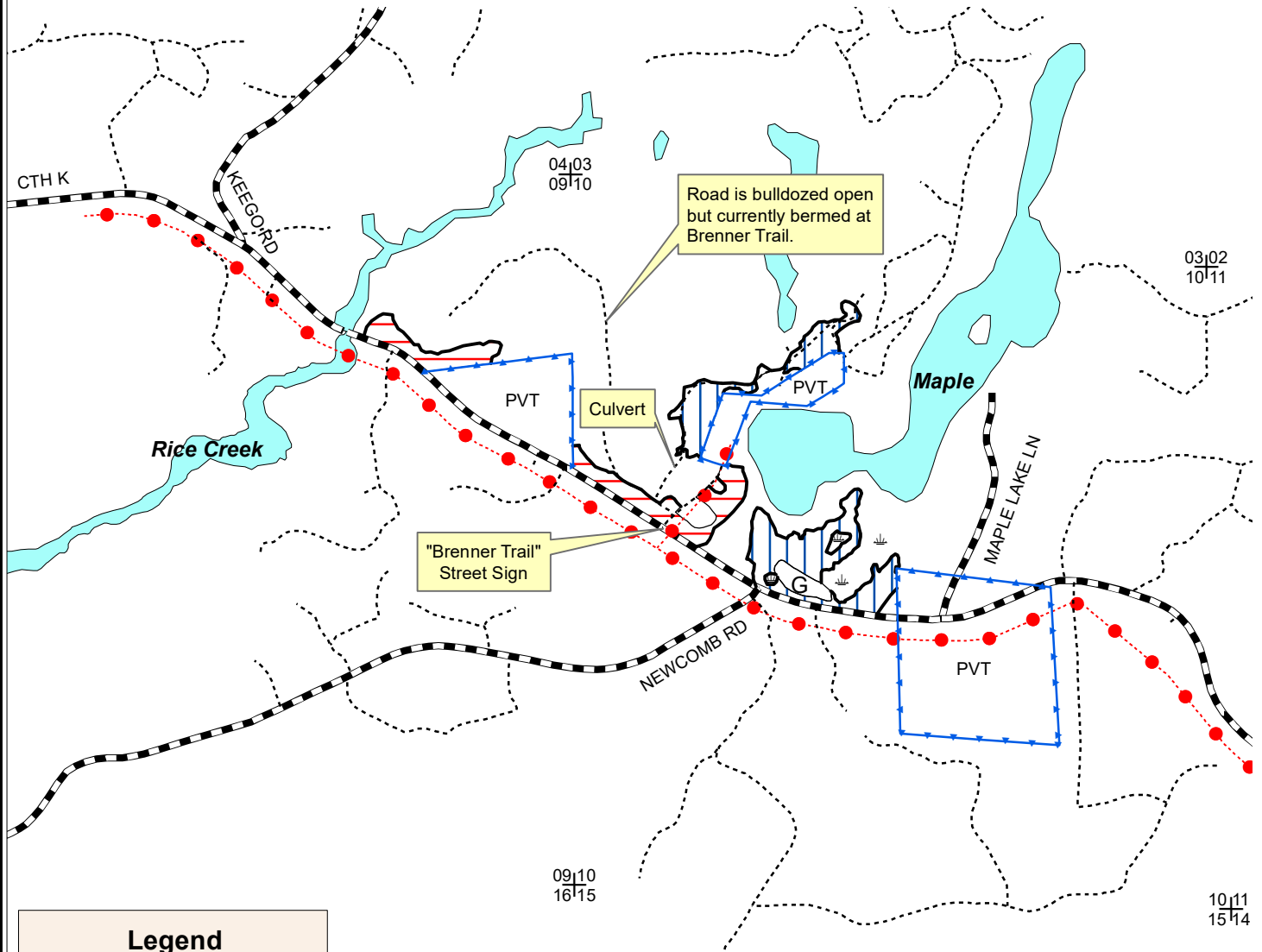
Weight conversions: Balsam Fir = 2.150 tons/cord \ White Birch = 2.387 tons/cord.

Sale volume equates to 24.1 tons/acre or 10.6 cords/acre.

Special Conditions

1. **LUMP SUM SALE.** 100% of the total lump sum bid value must be paid prior to starting. All trees are to be pre-approved prior to cutting if not marked or designated to be cut. Any residual trees cut, pushed over or damaged are to be decked, scaled and billed for in addition to lump sum bid value. Any trees cut without approval will subject the contractor to penalties and fines.
2. A culvert exists underneath the woods road to the southeast of the private residence. This must be protected by laying a protective layer of slash over it during harvest operations or by removing it and then replacing it when harvesting is complete.
3. There is an existing, overgrown driveway entrance opposite Newcomb Lane that will need to be opened to gain access to the sale south of Maple Lake.
4. Biomass harvesting is NOT allowed. Do not cut, knock down, or utilize dead trees unless the tree poses a safety hazard during harvesting operations.
5. Shortwood skidding only. Wood cut north and west of the houses must be skidded to the woods road where the berm is currently located.
6. All landings and any new roads must be approved prior to sale start up.
7. Slash must be pulled back ten feet from the tree line and must be lopped and scattered within 50 feet of the County Highway and Brenner Trail.
8. Cutting must be concurrent for all species to be harvested.
9. All pine products cut between May 1 and September 1 must be removed from the sale area within three weeks from time of cutting. Pine products cut during the remainder of the year must be removed prior to May 1 of each year.

Orange White Birch Area (18 Acres): Cut all merchantable aspen and balsam fir. Cut all pine, birch, maple, oak and spruce marked with orange paint.



Green White Birch Area (11 Acres): Cut all merchantable aspen, white birch and balsam fir. Cut all trees marked with orange paint.

Note: Do not cut trees marked with green paint.
