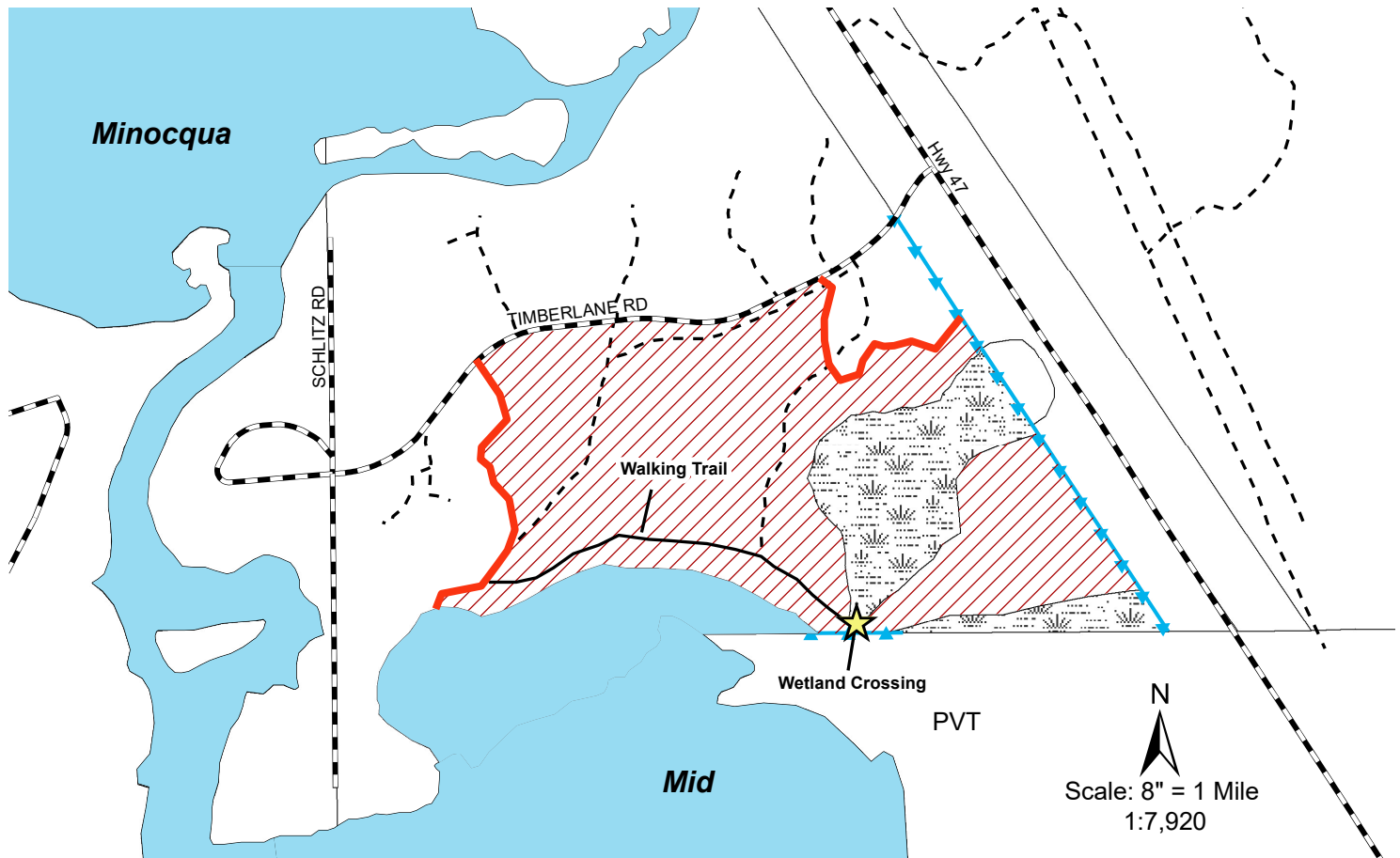

Harvest Area (39 Acres): Cut all merchantable maple, balsam fir, and all trees marked with orange paint. Do not cut any white birch, hemlock, cedar or green marked trees. Protect pine and oak regeneration in the understory.

Section 18 – Gov. Lot 6, NWSE

No bid bond is required.

15% of the total sale bid value will be required for performance bond.

The cutting area is approximately 39 acres.

The contract period is 3 years.

All trees that will yield one or more 100-inch sticks to the minimum 4” top diameter will be cut and utilized.

Biomass harvesting is not allowed.

¹ White pine is approximately 97% white pine and 3% balsam fir. Potential for 49 MBF of white pine sawlogs. (Wt. conv 2.101 tons/cord)

² Potential for 77 MBF of sawlogs.

³ Mixed hardwood is approximately 85% red maple and 15% red oak. Includes 2 MBF of potential sawlogs. (Wt. conv 2.336 tons/cord)

Total sale volume equates to approximately 31.9 tons/acre or 14.4 cords/acre.

Special Conditions:

1. **Timber mats or frozen ground conditions must be used to cross the wetland located at the southern edge of the sale.**
2. **An underground utility runs parallel to Timberlane Road. It is the successful bidder’s responsibility to contact WPS prior to sale start up.**
3. Cutting must be concurrent for all species to be harvested including non-merchantable trees where applicable.
4. **Equipment Restrictions:** Skidding of forest product materials will be restricted to shortwood skidders only.
5. Felling and skidding damage to residual trees must be avoided, this includes understory hardwood seedlings and saplings.
6. Do not cut, knock down, or utilize any dead trees unless they pose a safety hazard.
7. All slash within 50 feet of Timberlane road will be lopped and scattered to within two feet of the ground and pulled back into the sale area at least 10 feet from the tree line concurrently with cutting.
8. All existing woods roads must be left in good condition and be restored to pre-harvest condition upon sale completion. The walking trail depicted on the sale map must be kept clear of debris.
9. All pine products cut between May 1 and September 1 must be removed from the sale area within 3 weeks from the time of cutting. Pine products cut during the remainder of the year must be removed prior to May 1 of each year.
10. If the contract is to be worked on during multiple time periods a mid-contract “pull-off” inspection meeting will be required. One-week notice shall be given by the contractor prior to moving equipment off-site. During the “pull-off” inspection provisions needing attention will be documented. The contractor at this time can decide to remedy them before pulling off or rectify them when moving back onto the site. If the latter is chosen documented items shall be addressed before harvesting can continue.
