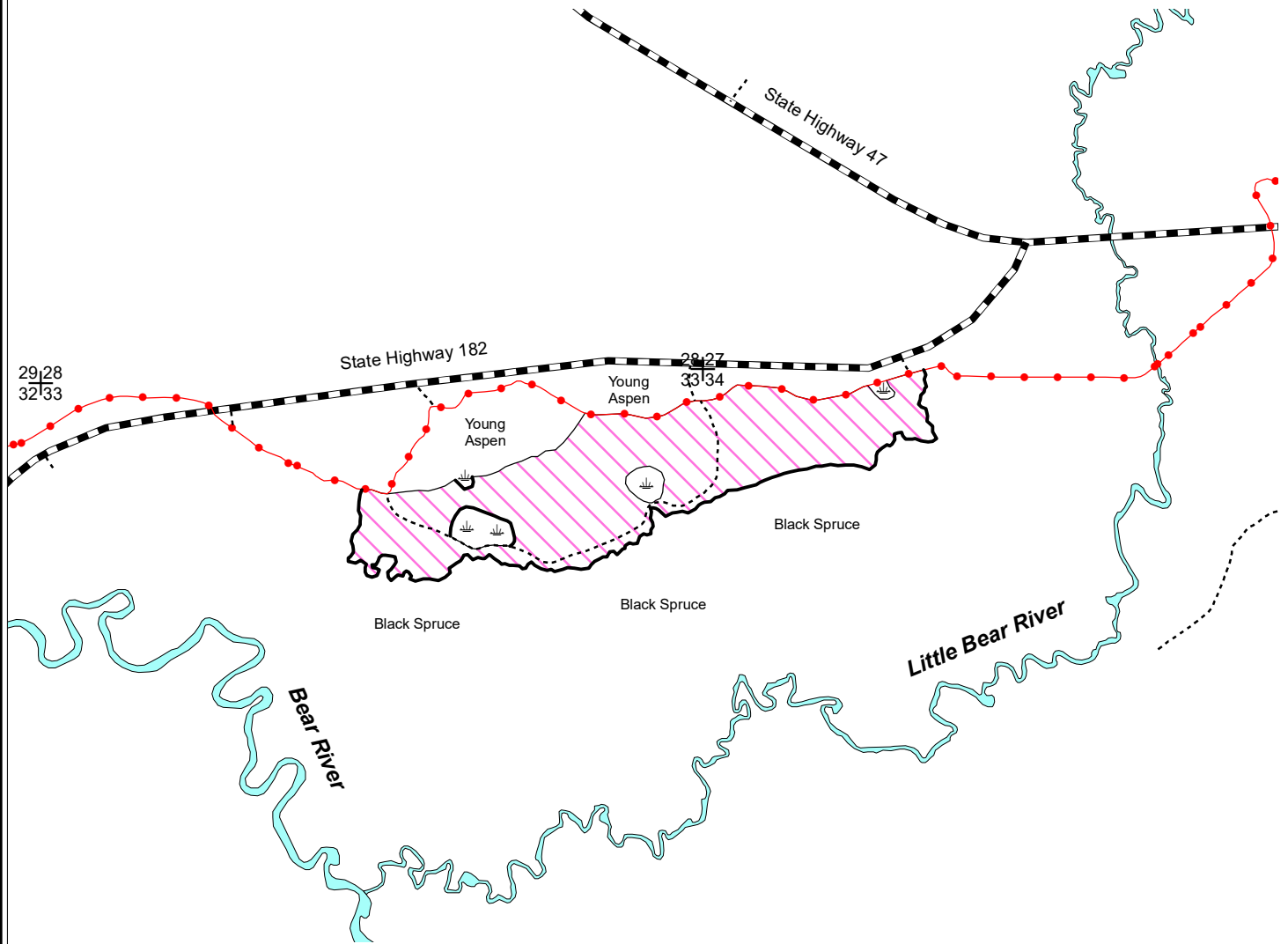

**Aspen Area (71 Acres):** Cut all aspen, white birch, maple, spruce and balsam fir. Cut all red and white pine marked with orange paint. Cut all maple 2 to 5 inches in diameter. Do NOT cut trees marked with green paint.

Rumbling Aspen

Iron County

Township 42 North, Range 4 East

Section 33 – NE1/4, NENW, SENW

Section 34 – NENW, NWNW

The cutting area is approximately 71 acres.

The contract period is 3 years.

All trees that will yield one or more 100-inch sticks to the minimum top diameter chosen by the bidder will be cut and utilized.

Whole tree harvest is allowed.

1\ F - 334 tons Balsam Fir, 96 tons Spruce, 26 tons Red Pine, 14 tons White Pine. Weighted average = 2.362 tons/cord.

2\ MX - 829 tons (includes 25 MBF) White Birch, 356 tons Red Maple and 15 tons Sugar Maple. Weighted average = 2.359 tons/cord.

3\ PR - 30 MBF Red Pine, 14 MBF Spruce and 9 MBF White Pine.

Sale volume equals approximately 51.7 tons/acre or 22.0 cords/acre (to a 4" top).

Special Conditions

1. Whole tree chipping and biomass harvesting is permitted.
2. All landings and any new roads must be approved prior to sale start up. All roads and the snowmobile trail must be graded level upon sale completion.
3. The snowmobile trail must be kept free of debris, snow covered in winter, and left in good condition for vehicle traffic at all times. The trail must be repaired to pre-harvest condition before the start of each snow season. Slash within 50 feet of the snowmobile trail must be lopped and scattered within two feet of the ground and pulled back into the sale area at least 10 feet from the edge of the trail.
4. All pine products cut between May 1 and September 1 must be removed from the sale area within three weeks from time of cutting. Pine products cut during the remainder of the year must be removed prior to May 1 of each year.
5. Cutting must be concurrent for all species to be harvested. All standing dead snags must remain standing unless they pose a hazard to operator safety.
