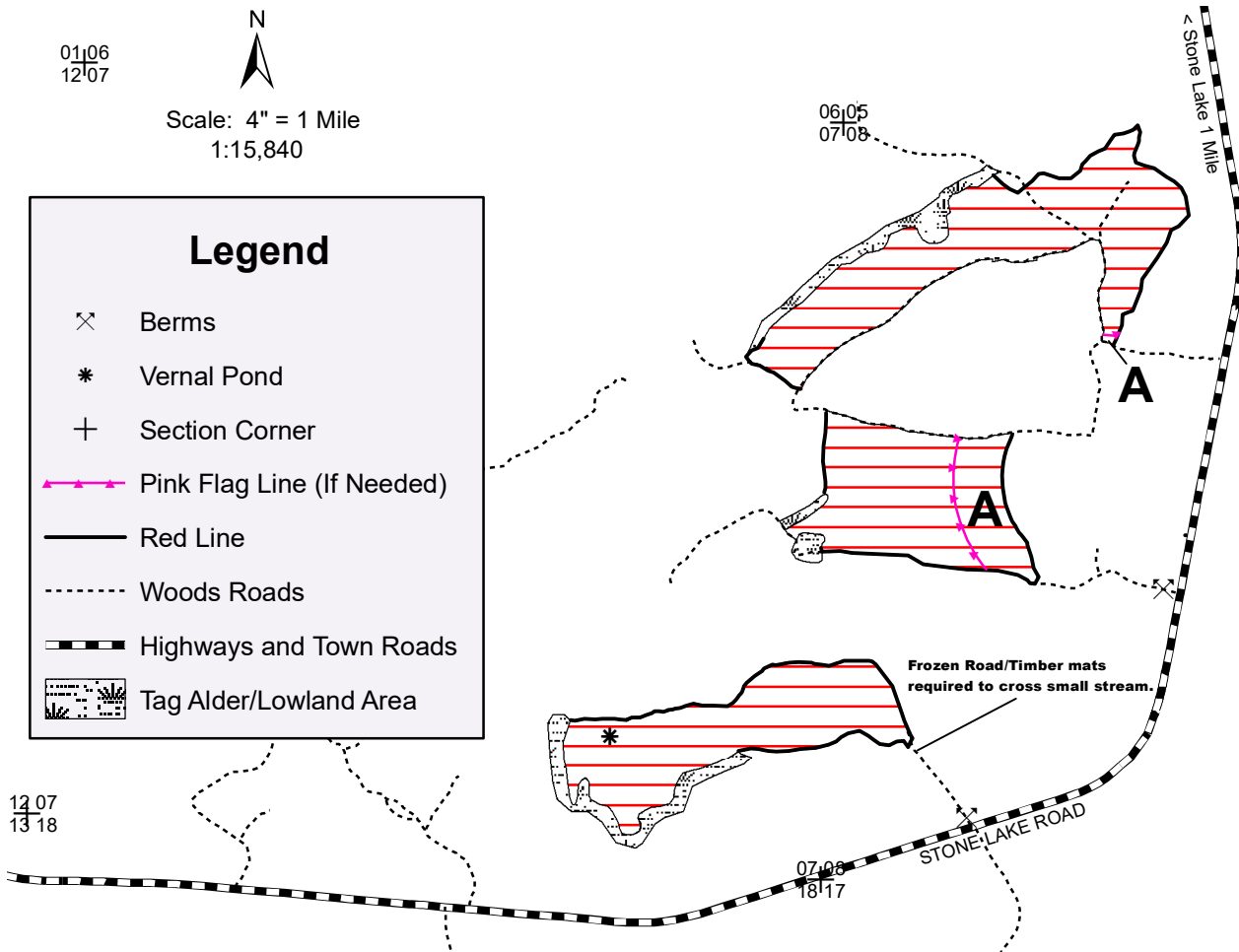

Note: All logging operations require frozen ground conditions. Do NOT cut any dead trees or trees with cavities. Do not cut green marked trees. No harvesting within 15 feet of any vernal ponds. SEASONAL RESTRICTION: In ZONE A, all logging operations must be completed once started. Operations, in ZONE A, will not be permitted from March 20 - July 31.



Aspen Regeneration Area (98 Acres); Cut all aspen, maple, white birch and balsam fir containing 3 or more pulp sticks. Leave all other species uncut.
Cut all 1-5 inch aspen and maple.

No bid bond required.

15% of the total sale bid value will be required as performance bond.

The cutting area is approximately 98 acres.

The contract period is 3 years.

All trees that will yield one or more 100-inch sticks to the minimum top diameter chosen by the bidder will be cut and utilized.

¹Volume includes 81% red maple, 14% white birch, and 5% sugar maple. Volume includes 8 MBF of white birch and 9 MBF of red maple potential logs. Weighted average conversion is 2.306 tons/cord. The total sale volume equates to approximately 54.69 tons/acre or 24.28 cords/acre based on a 4" top utilization.

Special Conditions:

1. **SEASONAL RESTRICTIONS:** All logging operations require frozen ground conditions. In Zone A, all logging operations must be completed once started within that winter. Operations, in Zone A, will not be permitted from March 20 - July 31.
2. A frozen road (ice road) and/or timber mats will be required, for a small stream crossing, to use the main woods road on the south cutting unit. Timber mats are available from the NHAL State Forest on a first come first served basis.
3. Cutting must be concurrent for all species to be harvested.
4. Leave all dead trees and obvious den trees standing unless they create a hazard to harvesting operations. If cut, leave snags where they fall. Do not cut any red, blue or green marked trees.
5. Do not harvest trees or operate machinery within 15 feet of any vernal pond and do not deposit any slash or tops in them. No tops or slash allowed in any grass opening or within any wetland.
6. All landings and any new woods roads must be approved prior to sale start up.
7. If the contract is to be worked on during multiple time periods a mid-contract "pull-off" inspection meeting will be required. One-week notice shall be given by the contractor prior to moving equipment off-site. During the "pull-off" inspection, provisions needing attention will be documented. The contractor at that time can decide to remedy them before pulling equipment off or rectify them when moving back onto the site. If the latter is chosen, documented items shall be addressed before harvesting can continue.

Notice: Completion of this form is mandatory. The Department will not recognize your bid unless you complete and submit this form. Personal information collected will be used for program administration and may be provided to requesters as required by Wisconsin's Public Records law [ss. 19.31-19.39, Wis. Stats.].

In the event the highest bidder can not or will not sign the contract, the award may be made to the next highest qualified bid.
