# **UTILIZATION**

- 1. All trees designated for cutting will be utilized to a 4 inch top and 10 inch diameter on the small end for logs unless stated otherwise in the prospectus.
- 2. When designated for cutting, all trees containing one (1) or more one hundred inch (100") long stick to a four inch (4") minimum top diameter will be considered merchantable.

## SCALING AND PAYMENT
