Hi Haley,

The Adams County Landfill Vertical Expansion project is covered by Table 1 of the [Broad Incidental Take Permit/Authorization for No/Low Impact Activities \(No/Low BITP/A\)](#), a formal ER Review letter is not needed and there are no actions that need to be taken to comply with state and/or federal endangered species laws. Any take that may result from the proposed project is permitted/authorized, and the ER Review fee is waived.

Specifically, the project is covered by Activity 1-A12, vertical landfill expansion, in Table 1 of the no/low: <https://dnr.wisconsin.gov/sites/default/files/topic/ERReview/bitpermit.pdf#page=6>. The no/low BITP/A covers projects that the DNR has determined will have no impact or a minimal impact to endangered and threatened species in the state.
