Dear Ms. Cooper,

As requested in your September 8, 2022, incompleteness determination of the Initial Site Report (ISR) for the Adams County Vertical Landfill Expansion, we are providing this Addendum #1 with responses to address the items listed in your letter. The items include those in your letter section titled, *information required to complete the ISR*, which have been transcribed below. Our responses follow each listed item.

**Information required:**

1. **Initial Site Inspection [s. NR 509.04(4)(d), Wis. Adm. Code]:** The department's ISI response letter indicated that submittal of a 7.5 Minute USGS map or equivalent with a minimum scale of 1 inch=500 feet would be required with the ISR because it was not provided with the ISI. Figure 1 of the ISR presents a topographic map of the regional area. Please provide a figure that meets the requirement of s. NR 509.04(4)(d), Wis. Adm. Code, for a 7.5 Minute USGS map or equivalent with a minimum scale of 1 inch=500 feet. Several maps at scale of 1 inch=500 feet may be needed to show all items listed in this code section. A plan sheet may be a more appropriate option than individual 8" x 11" pages.

Response: The ISR figures have been updated with a 1 inch=500 ft scale and are included as Attachment A.

2. **Submittal Requirements [s. NR 509.05(3), Wis. Adm. Code:]** The proposed base grades and final grades appear to be inconsistent. Please confirm the elevations and provide corrections as needed.

Response: The elevations provided in the ISR are confirmed to be accurate and presented below.

*Estimated Range in Base Elevations: 1014 to 1070 feet above median sea level (msl).*

*Estimated Range in Final Surface Elevations: 966 to 1,073.5 feet above msl.*

The lowest elevation in the range in final surface elevations (966 ft) corresponds to the lowest elevation of the final surface for Phases 3-6. Since the final cover for those phases has not yet been constructed and the vertical expansion surface cover will be constructed simultaneously with the cover of Phases 3-6, 966 ft was provided. The estimated range of surface cover elevations not including the previous phases would be 1014 ft msl to 1073.5 ft msl.

**3. Land Use Information [s. 509.06(1), Wis. Adm. Code]: Figure 3 of the ISR presents land ownership. Please provide the mailing addresses for all property owners whose property is contiguous to the county landfill property.**

Response: Refer to revised Figure 3 of Attachment A showing property boundaries and Attachment B, tabulated contiguous landowners and their mailing addresses.

**4. Land Use Information [s. 509.06(3), Wis. Adm. Code]: Please provide a copy of the 2015 Federal Aviation Administration (FAA) letter regarding the former Zanadu Airport that is referenced in the ISR.**

Response: Refer to Attachment C for a copy of the FAA letter.




# REGIONAL LOCATION MAP









Dear Mr. Free:

We are in receipt of your letter dated January 7, 2015 requesting Federal Aviation Administration (FAA) review of the proposed expansion of the Adams County Solid Waste Landfill near Friendship, Wisconsin in relation to nearby airport operations.

The FAA reviews proposed landfills and proposed landfill expansions in accordance with FAA Advisory Circular 150/5200-34A, "Construction or Establishment of Landfills near Public Airports" and FAA Advisory Circular 150/5200-33B, "Hazardous Wildlife Attractants On or Near Airports".

As stated in your letter, Zanadu Airport (WS04) is located approximately one mile to the west of the proposed landfill expansion. It appears from the latest airport database information that Zanadu Airport is no longer in operation. Regardless of its operational status, neither FAA Advisory Circular 150/5200-34A nor FAA Advisory Circular 150/5200-33B would apply to Zanadu Airport since it was a privately owned, private use facility. Additionally, Adams County Legion Field (63C) is located just over 5 miles to the south of the proposed landfill expansion. FAA Advisory Circular 150/5200-34A landfill siting criteria does not apply to 63C and 63C lies well beyond the 5,000 foot separation distance identified in FAA Advisory Circular 150/5200-33A.

Given the information above, the FAA has no objection to the proposed expansion of the Adams County Solid Waste Landfill near Friendship, Wisconsin.
