Proposed Solid Waste Landfill Vertical Expansion**

Dear Clerks:

Adams County Solid Waste Department (County) is by way of this certified letter formally notifying you of our proposal to expand its current solid waste landfill facility. The County currently operates a solid waste landfill located within SW ¼, NE ¼, Section 13, Township 18 North, Range 5 East, Adams County, Wisconsin.

The proposed landfill expansion consists of a vertical expansion for the 21.9-acre contiguous existing landfill. The expansion will overlay its waste from west to east of the existing landfill to promote a minimized landfill footprint. The limits of waste of the landfill will remain the same. The proposed landfill expansion footprint lies within property owned by Adams County Solid Waste in the Town of Strong Prairie, Adams County.

Pursuant to Section 289.22 of the Wisconsin State Statutes, the County hereby requests notification of any and all local approvals as defined by Section 289.33(3)(d) of the Wisconsin State Statutes for the establishment and operation of a solid waste facility.
