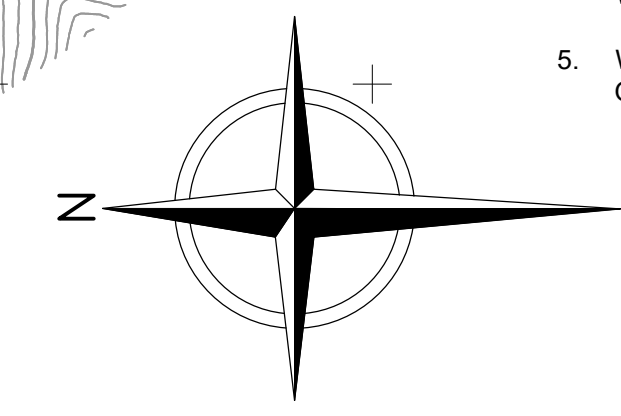

UPSTREAM STAFF GAUGE TYMAN-1 WAS LOCATED APPROXIMATELY 700 FEET NORTH OF TYMAN ROAD CULVERT SOUTHERN END. THIS MONITORING POINT WAS MONITORED FOR SURFACE WATER ELEVATIONS FROM 2000 - 2002 BUT WAS NOT INCLUDED IN THE 2002 APPROVED ENVIRONMENTAL MONITORING PLAN AND HAS SINCE WASHED AWAY DURING SPRING MELT EVENTS.
