



Permit history

Feb. 11, 1986 – Landfill Feasibility Determination issued by WDNR

Oct. 20, 1986 – Plan of Operation approval for 27.5-acre, 873K CY landfill

- Permitted under NR 180 Solid Waste Management; (preceded NR 500 regulations)
- Complied with NR 500 Solid Waste regulations that went into effect January 1988

Dec. 18, 1990 – Construction approval for Phase 1 of landfill

• Landfill operational but beneficial reuse diverts ash to asphalt, concrete and CWA

Dec. 19, 2013 – Landfill Feasibility Determination for proposed vertical and horizontal expansion of the landfill issued by WDNR

The new landfill would be composite lined and covered to comply with federal CCR rules

Permit history

Dec. 11, 2014 – Plan of Operation Modification approval – entire new landfill

- Approval for a 57.6-acre, 4.08M CY landfill to be development in 13 cells. Construction included new tank, improved access road, new stormwater management
- Gradient control system to maintain GW separation, composite base liner system 2 feet compacted clay, GCL, geomembrane and leachate collection system
- Composite final cover system compacted clay or soil barrier layer/GCL, geomembrane, 30 inches rooting zone and 6 inches topsoil

Feb. 1, 2023 – CCR Landfill Plan of Operation modification for Initial Permitting

- Original submittal Jan. 31, 2023, revised submittals Dec.19, 2023; and Aug. 23, 2024
- WDNR completeness determination Nov. 21, 2024

Landfill construction and operation history

Original landfill construction and operation

- Cell 1 Constructed December 1990, placed into operation; temporary GM cover 1992
- Beneficial reuse projects redirect ash to asphalt, concrete and CWA Safetyway Project 1991-2010
- Cell 1 exhumed and all waste removed and disposed at commercial landfill

Updated landfill facility:

- Cell1 and Cell 2 Constructed April 2016
- Cell 2 Placed into service June 2016 and partial final cover constructed in 2017 and 2020
- Cell 1 Placed into service August 2021

Overall landfill summary

Landfill – original permitting: 1986-1987

- Landfill feasibility 1986
- Plan of Operation approved 1986
- Originally 27.5-acre, 873K CY landfill
- Compacted clay liner (5 feet thick)
- Leachate collection system
- Compacted clay cover (2 feet thick)
- Cover soils (2 feet thick + 0.5 feet topsoil)

Landfill – updated permitting: 2010

- Vertical and horizontal expansion, 57.6 acres, 4.08M CY
- Entire original landfill exhumed and disposed at commercial landfill off-site
- Composite base liner and final cover system

CCR – updated design: 2024


- Liner and cover systems were in compliance with new rules
- Final cover geomembrane and 36 inches of soil


