LANDFILL

Target specific recommendations from Alternative Final Cover subcommittee

Discuss delaying synthetic liner capping/alternative landfill capping, or be able to reopen/refill subsided landfill air space

Site-specific landfill standards and post-closure "functional stability"

Long-term care and closure regulations and fee language

Possible recommendations:

Landfill short term: Utilize Alt Final Cover subcommittee again to target specific recommendations and determine path forward

Landfill long term: New subgroup to focus on post-closure functional stability and long-term care closure regs and fees

Landfill focus after two above are finished: New subgroup to focus on needs analysis and site life

#### RECYCLING/NON-LANDFILL

Change focus of recycling standards to include overall environmental (incl. GHG emissions) and economic outcomes

Recycling economic concerns

Management of hazards from new waste streams (Li-Ion batteries, e-cigarettes)

Possible recommendations:

Recycling/NonLF short term: Use of Study Group knowledge and recent DNR MRF survey to clarify and make recommendations on recycling economic concerns

Recycling/NonLF short term: Small group to determine assessment methods for recycling environmental and economic standards (use EPA's updated WARM model)

### GUIDANCE/RESEARCH/LEGISLATION

PFAS in leachate and wastewater

Diversion of recycling funding for non-recycling purposes and funding for RUs

Create one definition of recycling and how to define a successful recycling program

Supplement and clarifications to stormwater management guidance

Guidance Short Term: Small group to focus on supplement and clarification to stormwater management guidance

Research Short and Long Term: Full Study Group participation in recommendations related to PFAS in leachate and wastewater

Legislation: Small group to work on Definition of recycling; Diversion of recycling funding
