Facility Where Discharge Occurs: Clean Harbors ES Industrial Services, Inc., 1203 Klement St

Receiving Water And Location: Groundwaters of the state on approved land spreading sites including but not limited to the counties of Dane, Jefferson, Rock, and Walworth.

Brief Facility Description and Summary of Proposed Changes: This facility provides short term storage and land application of industrial liquid waste, liquid industrial sludge, by-product solids, and septage waste for numerous clients. Currently, HPC has approximately 250 fields approved for the land application of wastes. HPC's storage tank is located in the town of Milton, Wisconsin (Rock County).

Influent monitoring for flow rate has been changed to either industrial liquid sludge, industrial liquid waste, or kept as flow rate depending on the type of waste. This change does not impact the type of sample to be taken but does clarify what type of waste is at each influent sample point for record keeping. This parameter reporting has also been changes from "gallons per day" to "gallons per month". This parameter has also been changed from "measured" to "estimated"

Sample point 303 has had the sample type for total solids, total kjeldahl nitrogen, total ammonia nitrogen, total phosphorus, water extractable phosphorus, and total recoverable potassium changed from "Grab" to "Composite".

Sample points 306, 307, 308, 311, and 312 have had the following changes: Potassium and Total Phosphorus monitoring has been changed from Quarterly to Monthly; total solids monitoring has been changed from Annual to Monthly; and total solids units has been changed from mg/L to Percent.

Sample points 130 and 140 have had flow rate and fecal coliform monitoring added.

Sample points 737, 738, 739, and 740 have been removed from the permit.

The Department has tentatively decided that the above-specified WPDES permit should be reissued.

Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit. Land application of waste shall be done in accordance with permit conditions and applicable codes. All land application sites shall be approved prior to their use. To receive a list of approved sites, or to be notified of potential approvals, contact the above-named basin engineer.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
