PUBLIC NOTICE OF INTENT TO MODIFY A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0020958-10-1

Permittee: Village of Coon Valley, 205 Anderson Rd, Coon Valley, WI 54623

Facility Where Discharge Occurs: Coon Valley Wastewater Treatment Facility, 200 Jack Berg Ln, Coon Valley, WI

Receiving Water And Location: Coon Creek in the Coon Creek Watershed of the Bad Axe-La Crosse River Basin in Vernon County

Brief Facility Description: The Coon Valley Wastewater Treatment Plant treats domestic waste from the Village of Coon Valley and the Town of Coon. The annual average design flow of the facility is 0.181 million gallons per day (MGD) and the actual annual average influent flow in 2021 was 0.044 MGD. Treatment is via a three-celled aerated lagoon system. The permittee will at times be operating the lagoon system as a modified fill and draw during the spring and fall turnover conditions or during episodes of heavy algae growth, not to exceed the design flow. The Village usually uses retention time to meet their fecal limits, but also has the ability to add chlorine for additional disinfection if needed prior to discharge to Coon Creek, which is categorized as exceptional resource water. An upgrade occurred during the last permit term to allow for chemical addition for phosphorus treatment.

Proposed Modification: The permit modification is proposed to reduce the effluent PFOS/PFOA sampling frequency from 1/2 months to annual, after a review of submitted data, pursuant to s. NR 205.066, Wis. Adm. Code. Additionally, there's a typographical error in the Variable Daily Maximum Ammonia Limits table (Section 2.2.1.2 of the permit) that has been fixed at this time as well.

The Department has tentatively decided that the above-specified WPDES permit should be modified.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary.
